2.1 Getting Started

2.1.1 Tasks

Tasks are part of a process that was set up by an administrator of the project using workflows. A task is an activity assigned to a project member. You can find your tasks in

and change your task [communication preferences](#) in the profile dialog.

Dashboard

The dashboard app shows you the open and overdue tasks you are assigned to. Click on the task to open the details for the task. (2.1)

My Tasks

In the My Tasks app on your left you can easily view all the open tasks that are assigned to you. Each task shows the question that is asked and a selection of predefined answers you can choose from. (2.2 on the next page)

Comments For each task, you can add a comment in case you wish to clarify your answer.

Attachments You can add documents from your local machine or from Bricsys 24/7 related to the answer to your task. On the bottom of the task, you find the document the task is attached to and the workflow the task is part of.

Document Click on the document preview to open the document in our online viewer or the document name to open the document details.

Workflow For those interested, you can also view the workflow of which this task is part of and see the history of all the tasks executed before you.

Filter Do you have too many open tasks and need to focus on a specific set of documents first? It's possible to filter your tasks by metadata, folder, and even workflow. On the top panel of the app, you'll find the filter options. [\(2.3\)](#) [\(2.4 on the next page\)](#)

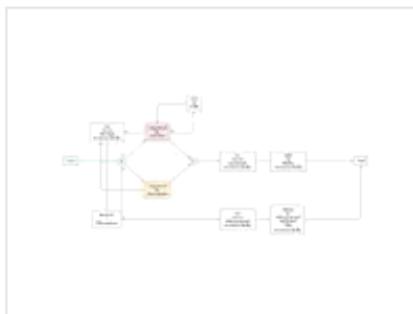

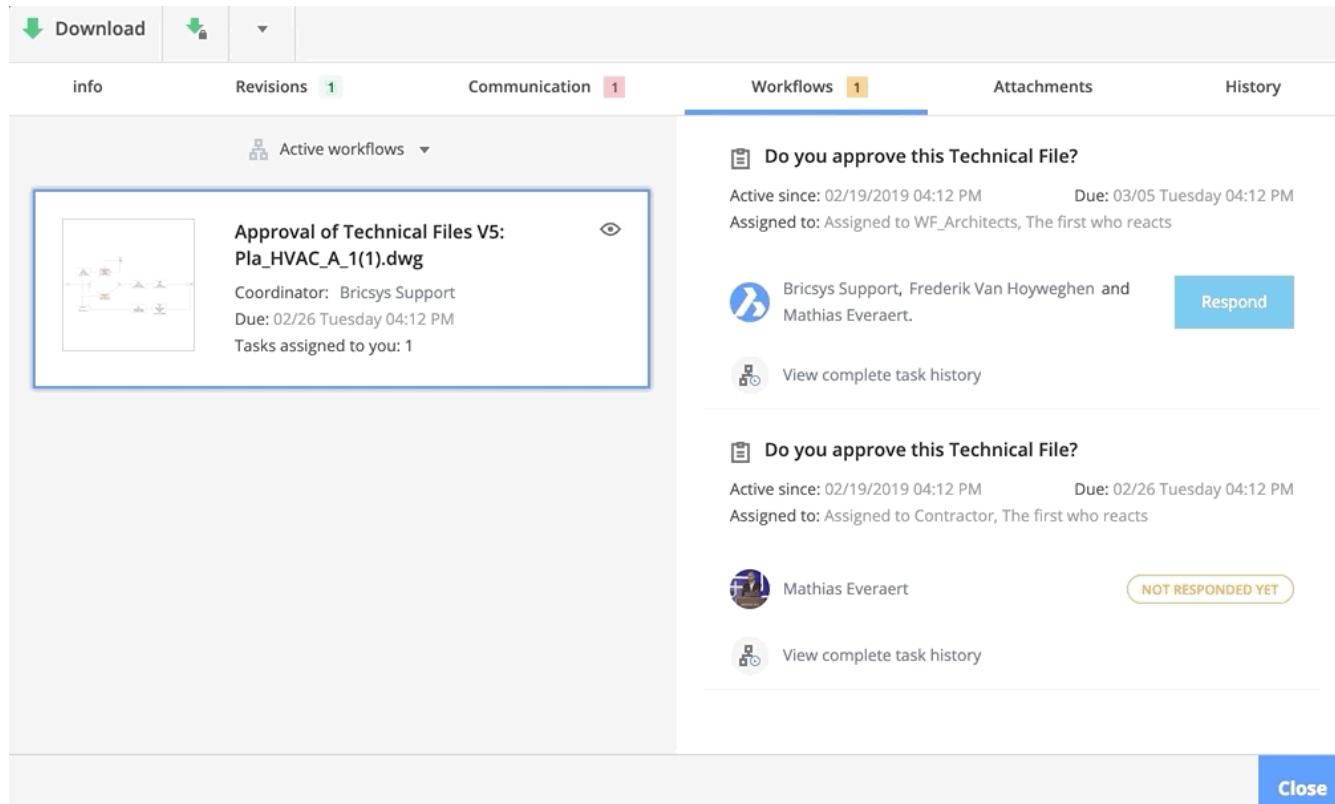

2.1.2 Working with documents

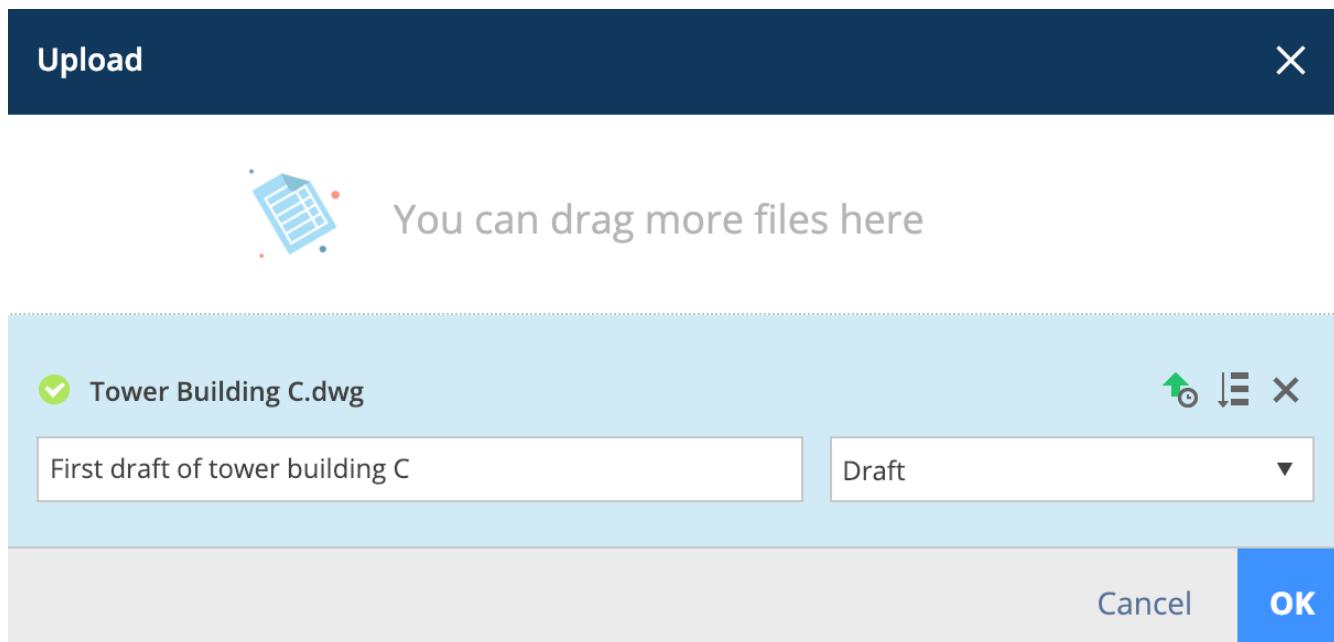
Structure app

The structure app is the only app that gives you access to document and binder folders. Binder folders contain a collection of items. Document folders are shown with a grey icon, if the folder has documents it will be dark grey and if it's empty it will be shown with a light grey color. Let's open a document folder.

Upload

Click on the upload button in the action menu to upload a new document. The dialog will ask you to select one or multiple documents you wish to upload. You can drag and drop the documents directly from your local machine to the upload dialog or manually select them. (2.7) Once the documents have been added, the dialog will show

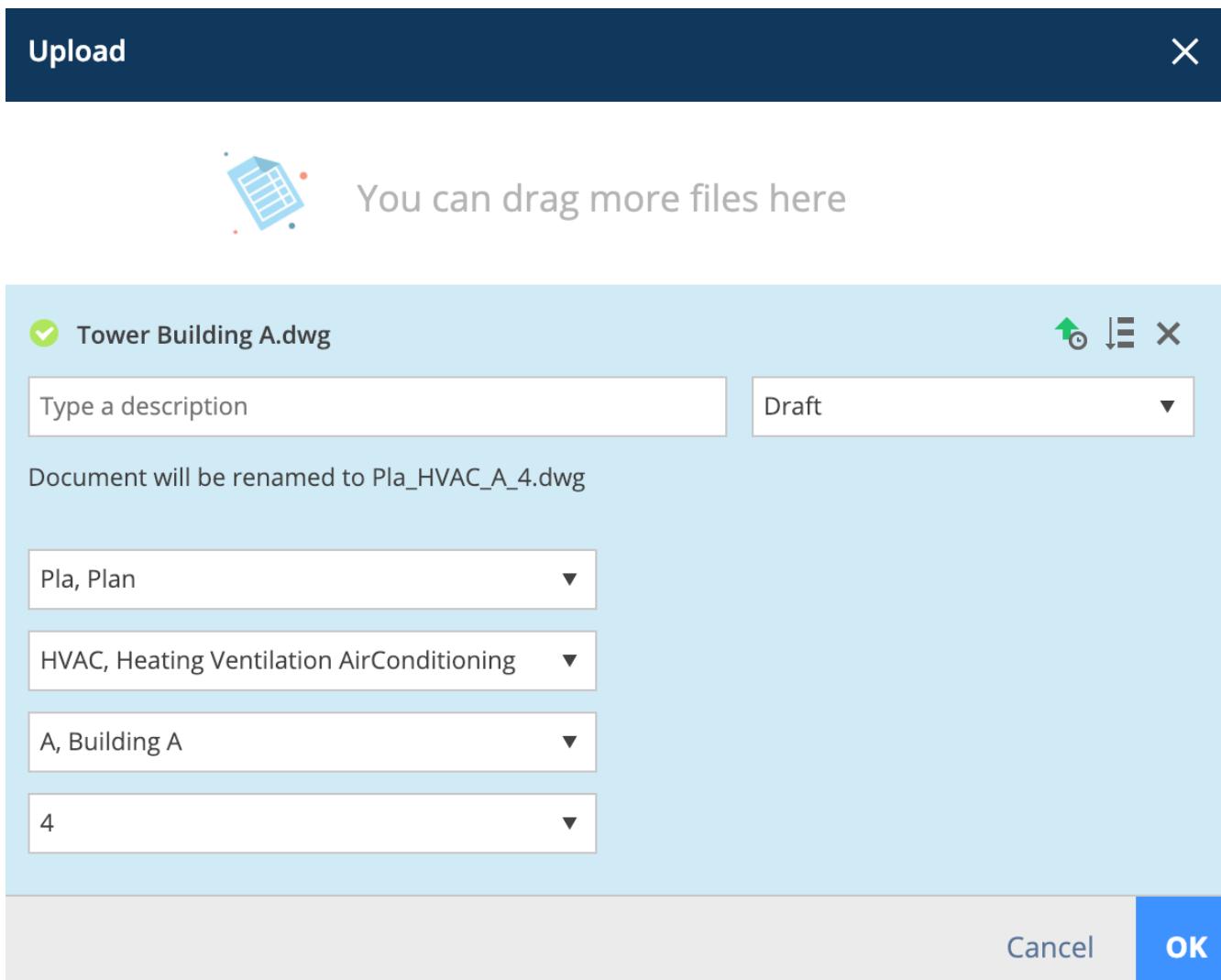

the upload progress with a blue progress bar and ask for an optional description and a document status. In case you see more fields popping up it means the administrator has set up metadata for this folder. Metadata is a great way to add more detailed information to a document in order to easily search, filter and group documents.

(2.8 on the next page)  If you want to add the same values for all the documents, simply click the "apply to underlying documents" icon to set the values. Hit the upload button to add your documents to the folder. If you need to upload a huge set of documents at once, you can use our transfer tool.

Online viewer

Once a document is uploaded and our online viewer supports the document format, Bricsys 24/7 will undertake multiple actions to make the document viewable online.

Columns

Document Inspector The top right of the table contains the document inspector column. It gives you a quick overview of some of the details of a document. ([2.9 on the facing page](#))

	How many revisions were made
	How many annotations were added
	How many notes were added
	How many workflows were attached
	How many times has this document been shared
	How many other documents are linked to this document

If you hover over the fields in the document inspector, more information will appear. If you click this information, you will jump immediately to the linked information. Sometimes there is a colored line underneath the number of workflows:

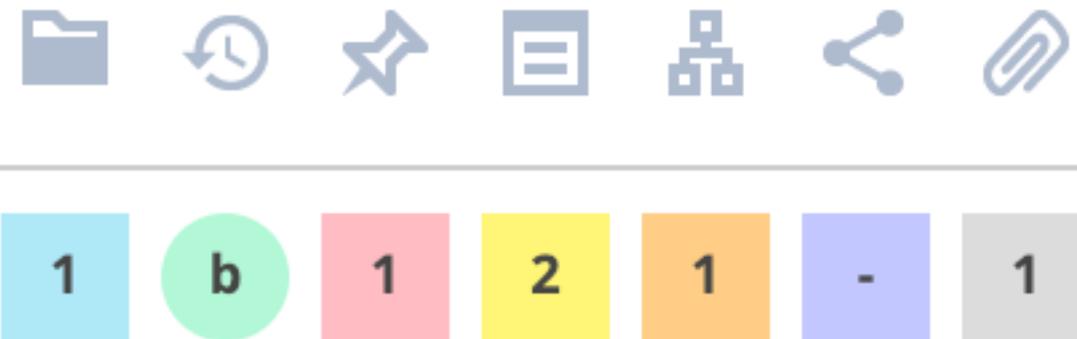


green means that the workflow is finished

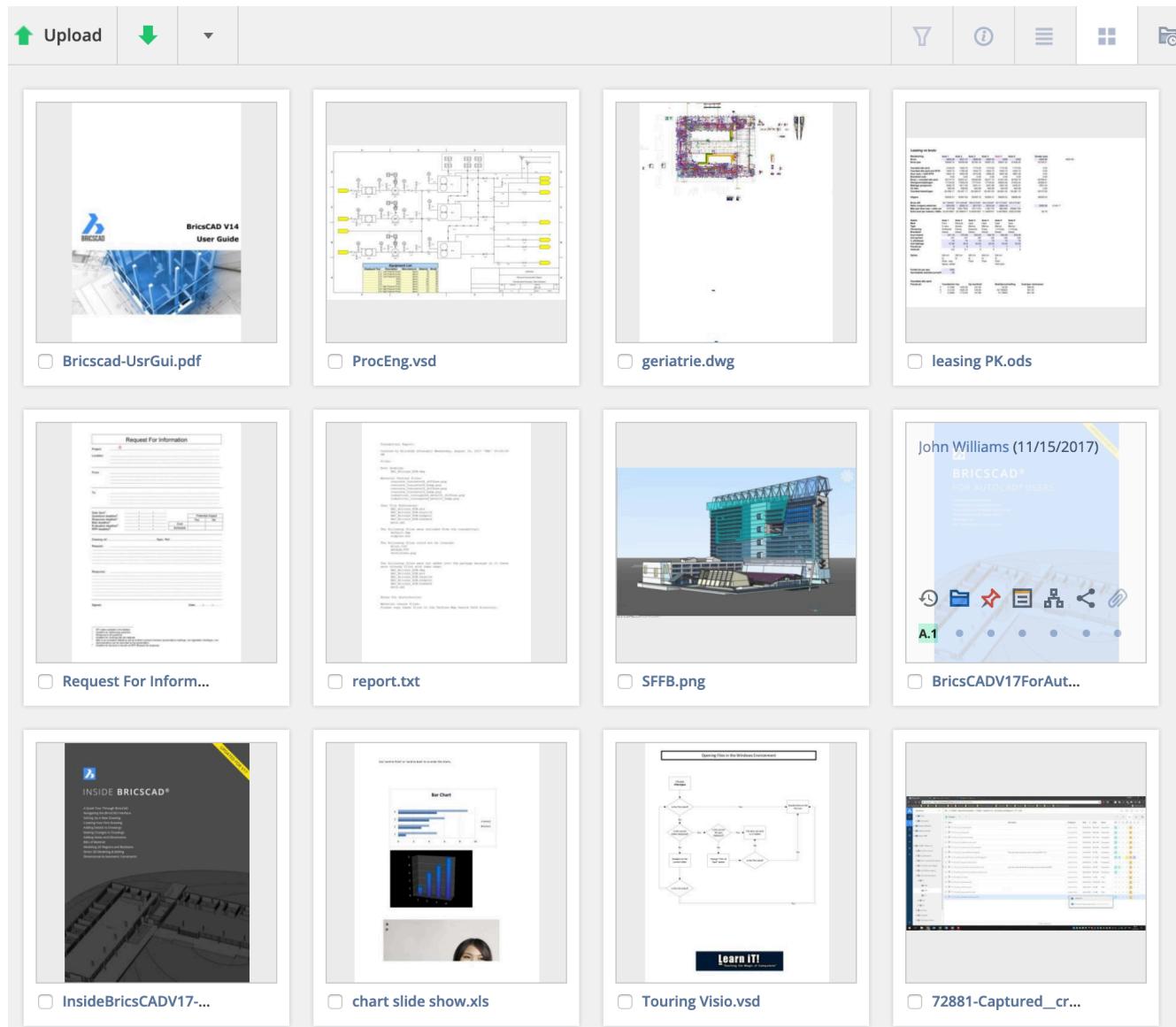


Column selector If you want to hide columns or show extra metadata columns in case the folder has metadata, you can click the "..." icon on the top right and click the columns you want to show or hide.

Thumbnails

On the top right you can switch to thumbnail view, this gives you a visual overview of the documents in the folder. [\(2.10 on the next page\)](#)

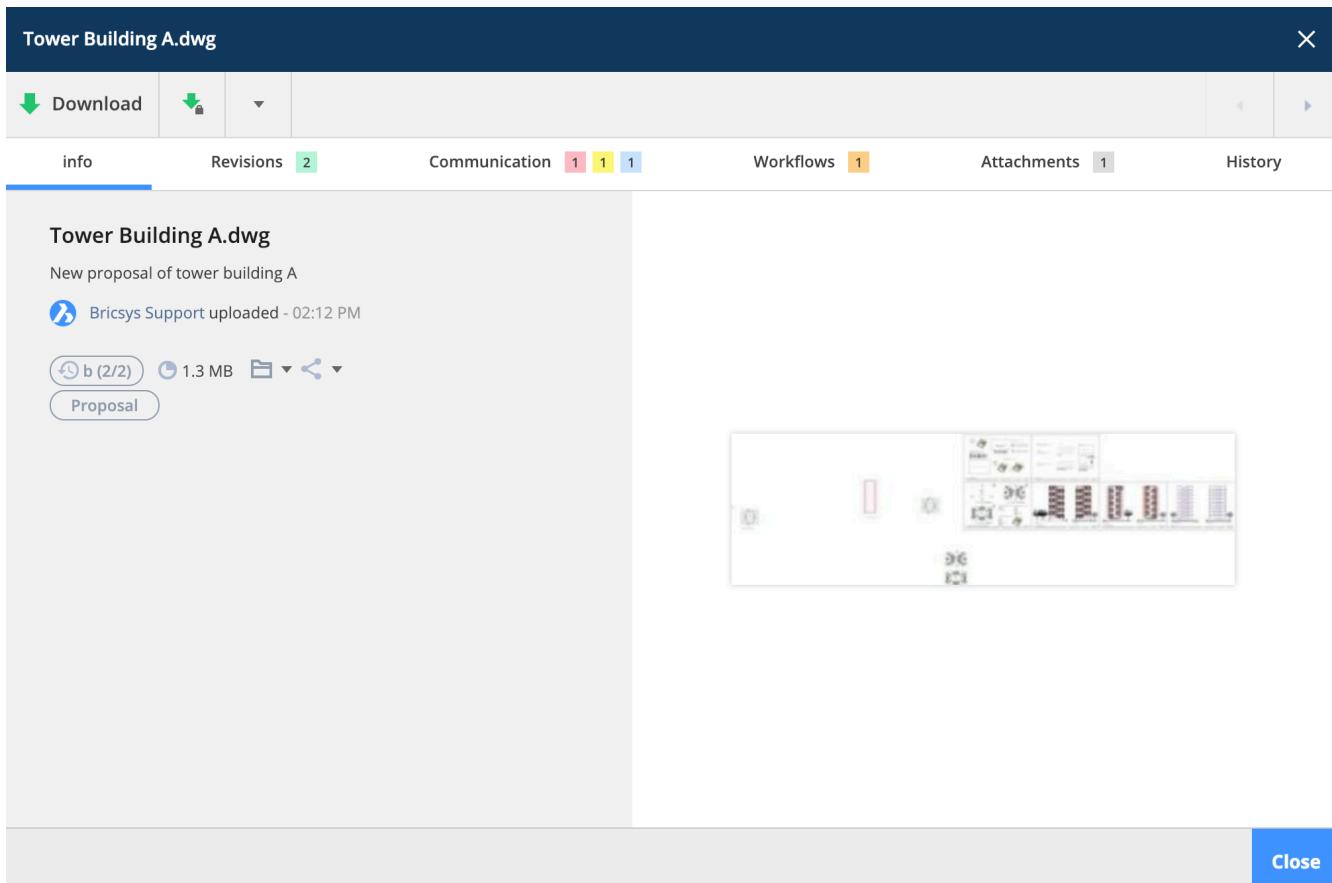

Document details

By clicking on the document name you open the document details dialog. This dialog contains all the information of a document. (2.11 on the facing page) The tabs on top of the dialog group the information by category.

Info Contains the same information as the columns in the document app as well as the locations where the document is displayed: folder and binders and if the document has been shared publicly. Click on the preview on the right to view the document in our online viewer.

Revisions The process from draft to delivered document is saved by revisions. Each revision has a status and description to indicate its process. This section contains all the revisions a document has. There is no limit on the number of revisions. The administrator decides how revisions are displayed:

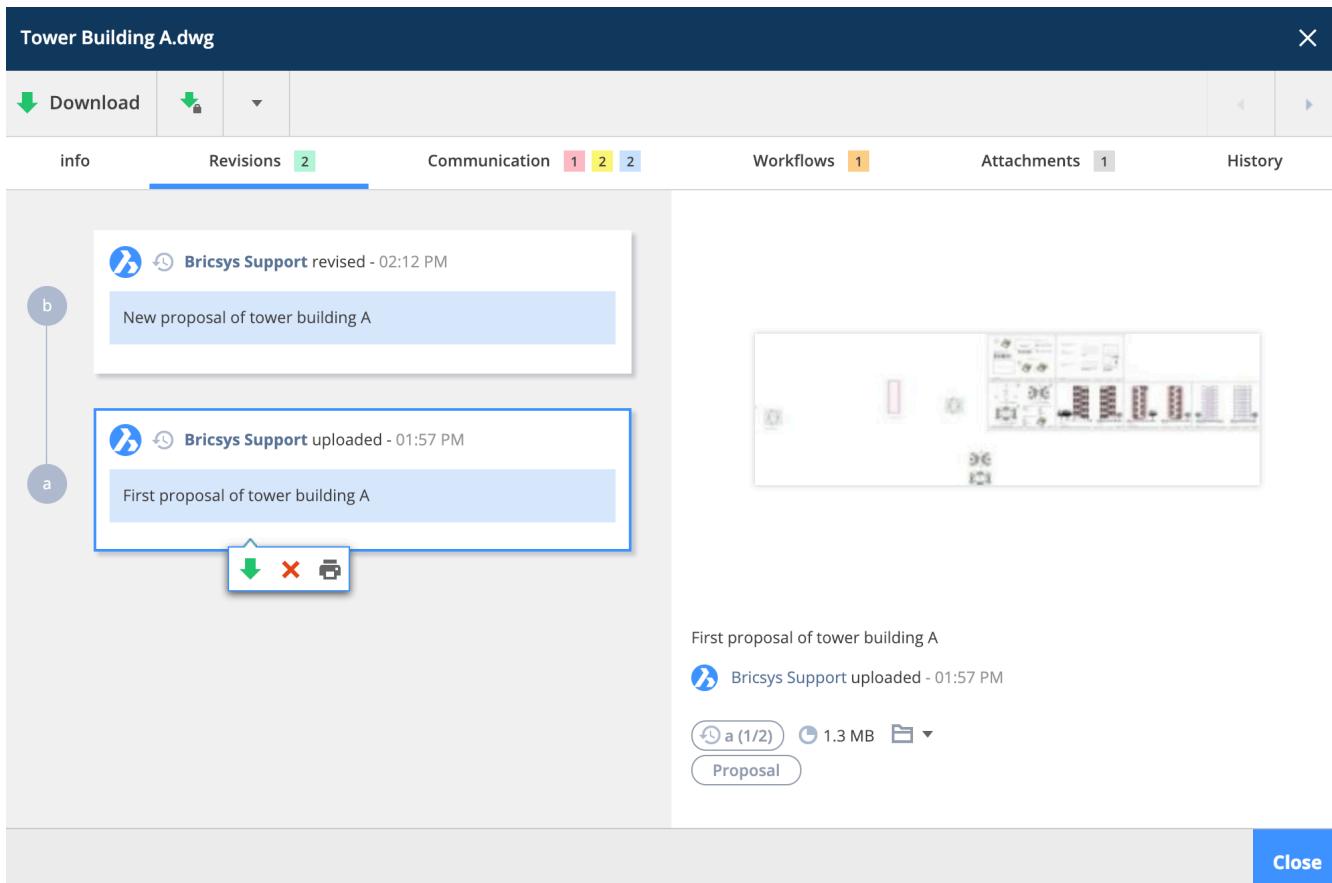

Revisions can have a major and minor version. This is decided by the administrator of the project. This way a revision could be "A.1" instead of just "1". Click on a revision to view the details of the revision on the right. ([2.12 on the next page](#)) Hover over a revision to

- Print to PDF
- Delete (only if you have delete access on the document and the project administrator allowed the deletion of revisions)

Clicking on a specific revision will filter the communication and attachments in the corresponding tabs to the selected revision.

Communication View all the communication concerning this document, easily filter on the type of communication and revision.

Workflows View the workflows that are active, finished or canceled. If a workflow has active tasks and you are assigned to a task, you can respond to the task from here.

Attachments View all the items that are linked to this document and the items the document is part of.

History Take a look at the history of this document.

Action menu

The menu on the top will show you which actions you can perform in this document folder. This is set by the administrator of the project. (2.13 on page 20) Some actions are based on selections only. If the folder has documents you can hover over a document and see the actions available on that document. (2.14 on page 21)

 **Delete** When you delete a document it will be stored in the recycle bin. Only the administrator can access the recycle bin and delete it definitively or restore it to the original document folder. You can't delete a document and upload a document with the same name because the deleted document is stored in the recycle bin.



Attach document

Gives you the opportunity to manually upload a new document from your local machine and attach it to the document directly or link the document to another document in your project. When linking to another document on the project the advanced options let you choose whether you want to link a specific revision to a specific revision. By default the documents are always linked to the last version of each document. (2.15 on page 21) Once the document is linked you can see it in the [document inspector](#) and in the details of the document. If it is linked to another document, you will see the link in the other document as well. When uploading dwg files from within BricsCAD or AutoCAD with our [Bricsys 24/7 connect plugin](#), xrefs will be linked automatically for you.



Public share

Share documents with people who aren't part of the project by creating a unique URL and send it to them. Everyone with this link can open the document in the viewer without them having to log in on the project. ([2.16 on page 22](#))

You can always turn off the share by toggling the public share slider on the top right. After you turned off the sharing, the URL link will no longer work. Watch out: If you re-share by doing the same action, another URL will be generated, different from the old UR you generated the first time.

Transfer tool

With the transfer tool, available for Windows and Mac, you can easily upload hundreds of documents and folders to Bricsys 24/7. As an admin, it's also a great tool to set up a project structure in a couple of clicks.

2.1.3 Profile Settings

Click on the profile picture/avatar in the top-right corner of the Bricsys 24/7 screen. Here you can edit your profile settings.

Pay attention! If you cannot edit this information, it means that the administrator did not give you the rights to edit your profile. (2.17)

1. Edit personal details

Edit or fill in your personal details, avatar, address and/or contact details. If your email address has changed you can change it here to login with the new email address.

2. Choose your interface language.

Change the interface of Bricsys 24/7 to your preferred language.

3. Send me a daily overview

If you want a daily mail with all your notifications.

4. Send me a daily task overview

If you want a daily mail with all your open tasks.

5. Stop task notifications

If you do not want to get an e-mail notification when you are assigned to a new task.

6. Add revision to document name on download

If you want to add the revision to the document name when downloading. The revision will be added after the document name: document-**revision**.extension Example: document named "PL_HVAC_001.dwg" with 3 revisions: A, B & C. When downloading the document it will be saved as "PL_HVAC_001-C.dwg"

7. Change your password

If you want to change your password.

8. Folder subscription overview

This option is only available once you log into a project. When you subscribe to a folder, you will get a notification e-mail when something changes (upload, new revision, edit of a document...) in this folder. The administrator of your project can also subscribe you to certain folders. These subscriptions cannot be undone, only the administrator has to right to update these.

9. Access tokens

For advanced users only. If you have a third party application that needs to connect to Bricsys 24/7 via our REST api, you can create a token here so you don't have to give your personal credentials (username and password) for the application to login to Bricsys 24/7. The application will have the same access using the token as yourself. Once created you are also able to revoke the token, disabling the access for that application to Bricsys 24/7.

10. Merge your account

Merge the Bricsys 24/7 account you're logged in with, with another Bricsys 24/7 account by entering the username and the password of the other account.

11. Connection info

If you want to find basic information about your connection to Bricsys 24/7 you can use this action. Your download speed, browser, operating system will be shown here. Especially useful when you are submitting a new support request so our team has a better understanding of your local environment.

2.1.4 Communication

Communication is the beating heart of project collaboration in Bricsys 24/7. In your profile you can review your communication preferences.

Types of communication

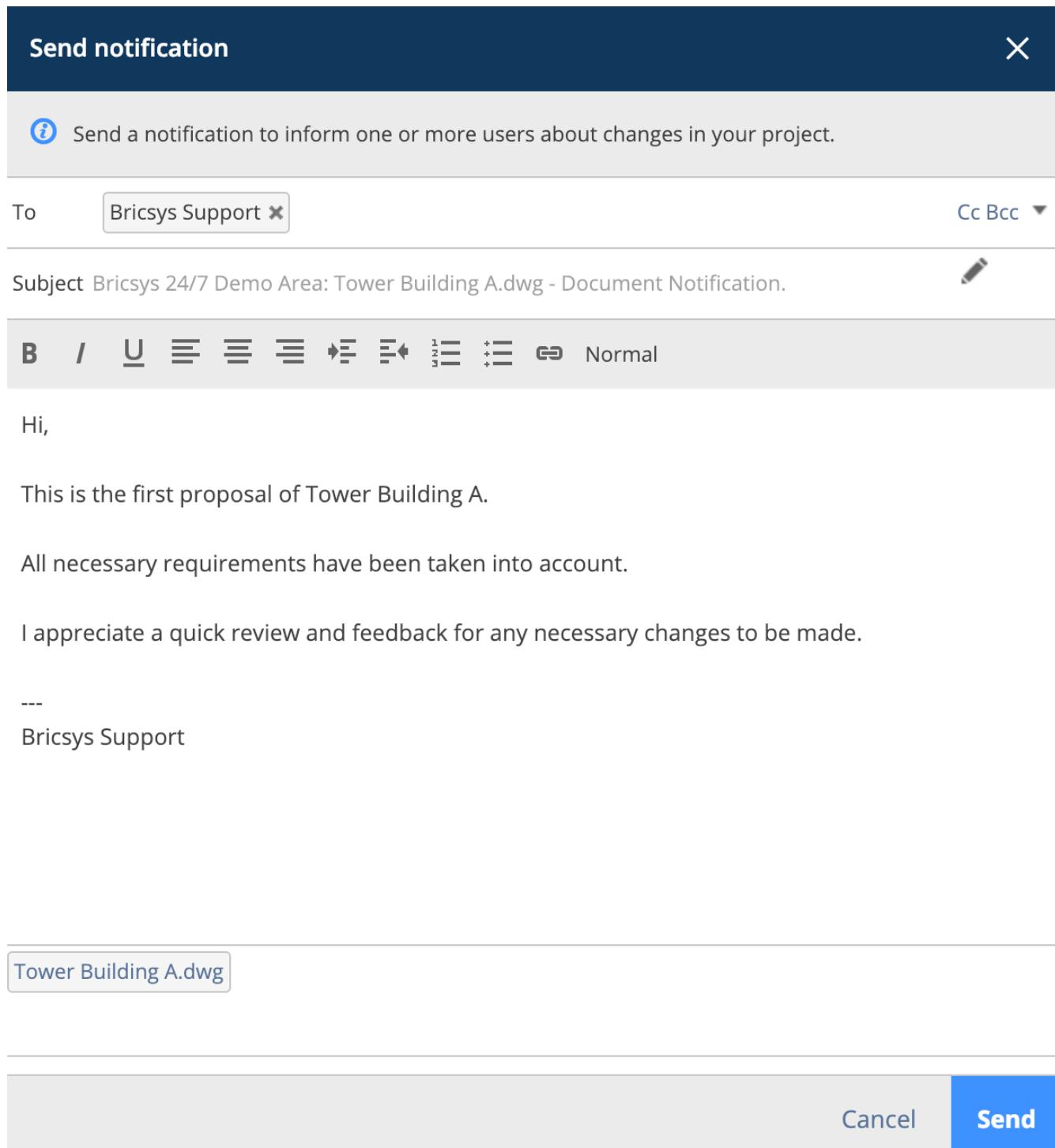
In Bricsys 24/7 we have four types of communication

Notifications

Easily inform other project members that can view the item about it. Typical examples are sending a notification about a newly uploaded document, a selection of documents etc. Add the recipients, just like you would do for an email, write a subject and a message. The recipients will receive an email with your message and the items you are referring to. ([2.18 on the next page](#))

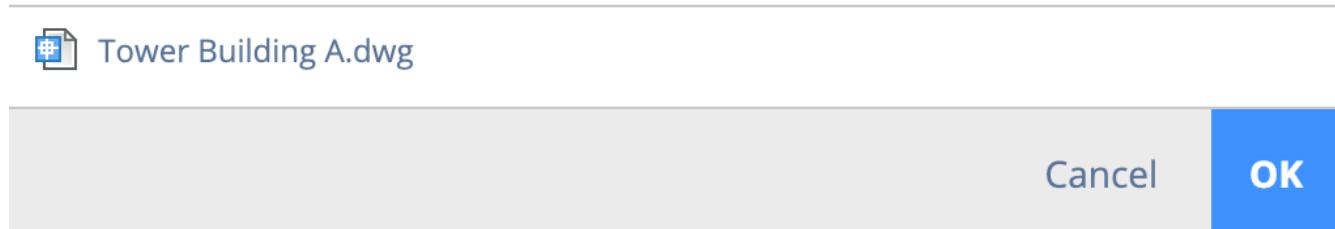
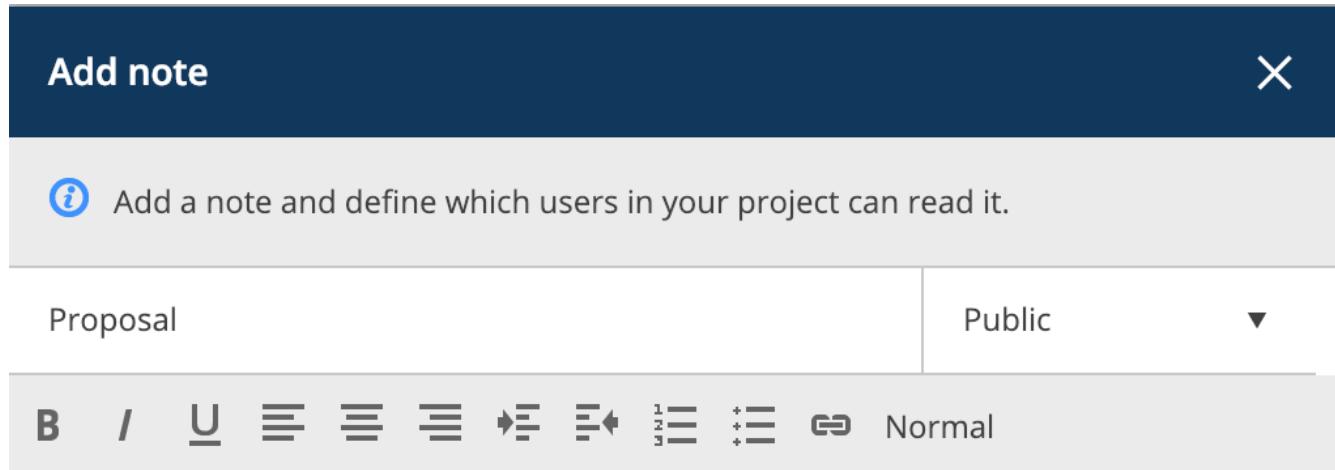


Notes

Just like sticky notes, a note is visible over all the revisions of a document. You can use private notes or public notes.

Private note When you select members of the project in the note, the note becomes private and only those who are a recipient of a note can view the note. ([2.19 on the following page](#)) Note that administrators can enable a feature allowing them to view all communications, including private communication.

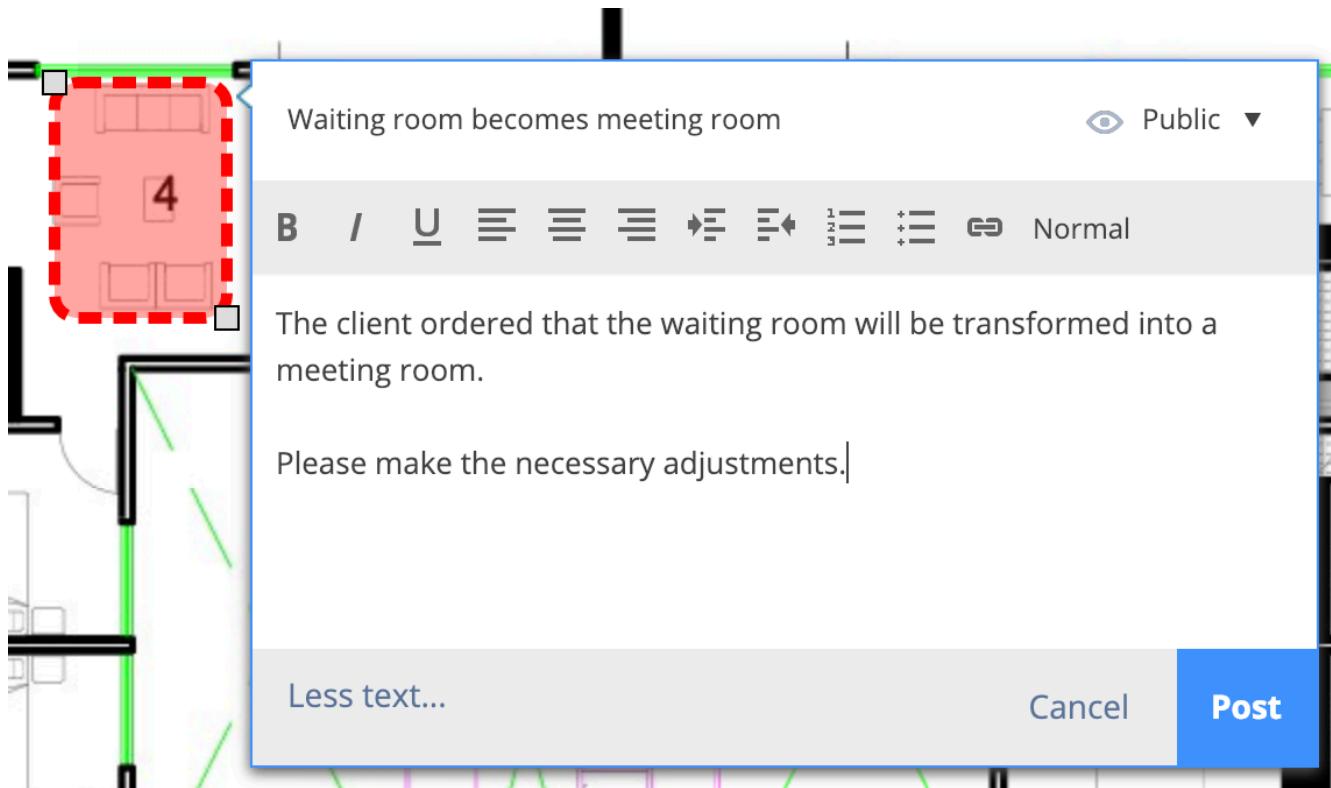

Annotations

A great way to mark an area of a document and comment about it. Annotations can only be created in our online viewer. Simply choose the type of annotation you want to add, select the area and add your message. By default only a subject is shown, click on the “more” link to add a description to your comment. (2.20) Annotations are

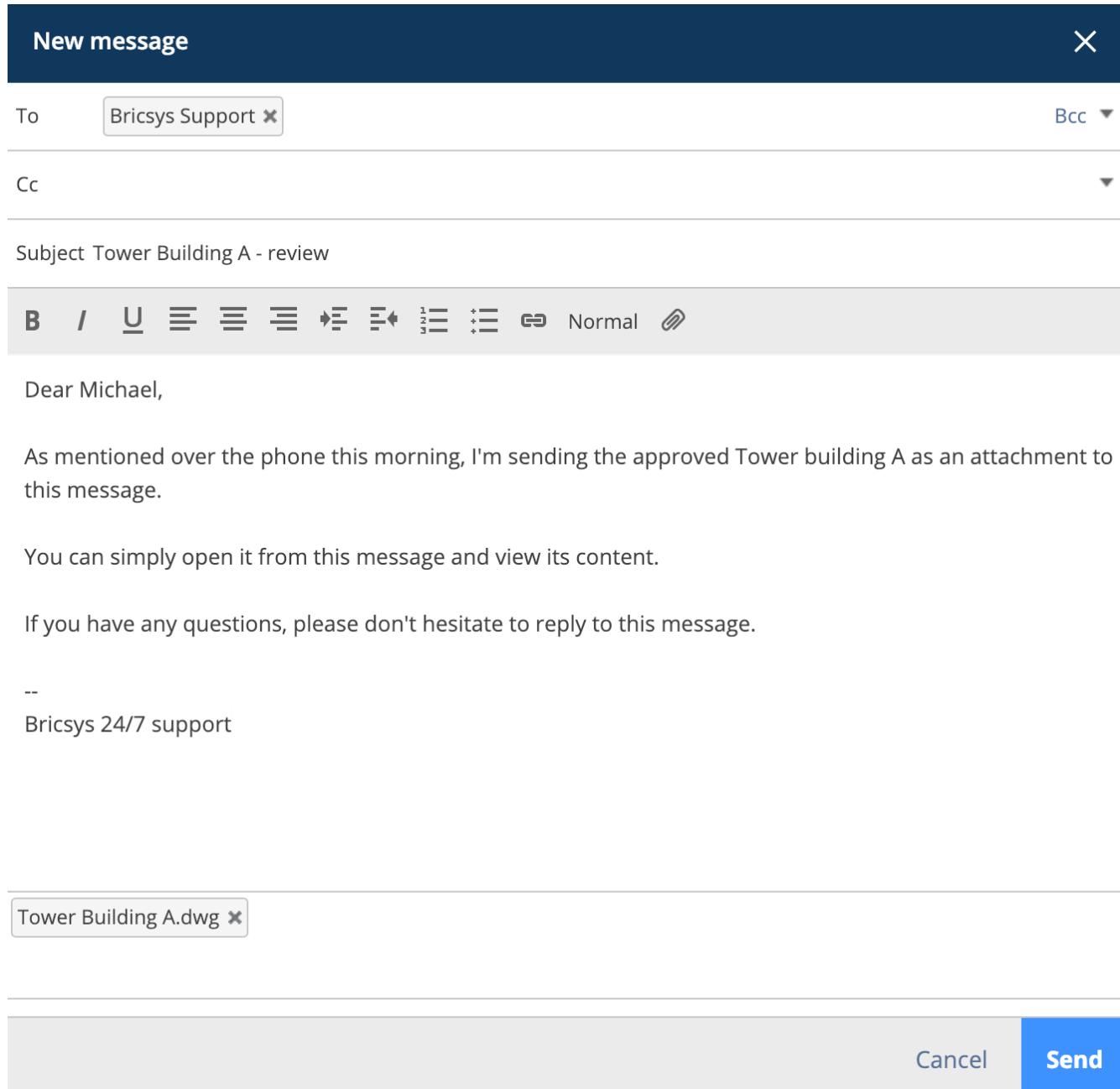


revision based, this means you cannot see the annotation of previous revisions when viewing the latest version of the document.

Messages

Messages works just like your email does but it doesn't get lost, keep track of your emails. It's a great way to communicate effectively with other project members and not lose the information. (2.21 on the following page) The administrator of the project can also enable email forwarding for a specific email address. This makes it possible to send an email to the specific email address and have the email appear in Bricsys 24/7.

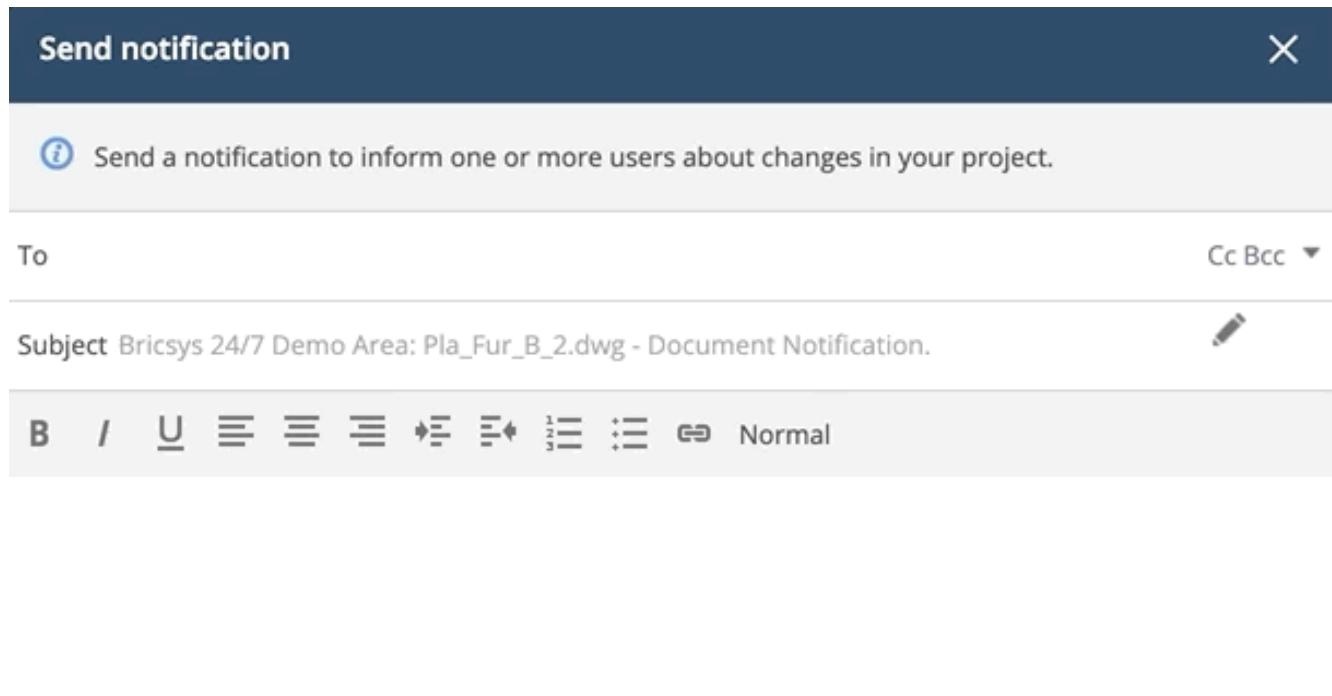

Recipients

Keep in mind that only project members who can view the item will be selectable. Simply type the name of a project member or select one of the mail lists setup by the project administrator. After selecting a mail list, you can click on the list to deselect certain members. ([2.22 on the next page](#)) If you cannot send a notification or assign members in a note or mail message, this means that the administrator of the project did not give you access to communicate with other members of the project.

2.1.5 Layout and functionalities

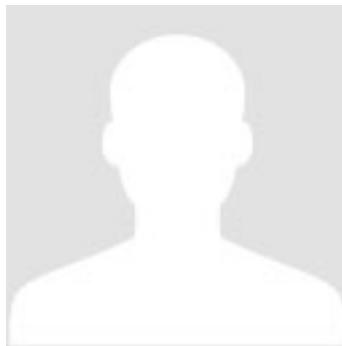
In this part of the Bricsys 24/7 help you find the default layout and grouping of the functionalities on Bricsys 24/7. Bricsys 24/7 contains a Project Bar(1), an App Bar (2), an App Menu (3) and an App Content (4) with Actions (5) and Views (6).

1. Project Bar

On top of the Bricsys 24/7 screen sits the Project Bar with basic information and basic actions.

Displays a list of all your projects. Click a project in the list to open the project. Only one project can be opened simultaneously.

A quick and easy way to find what you're looking for. Simply type the first three letters of what you need and all results will popup under your search query. Optional: Advanced search The advanced search lets you specify specific criteria to narrow down search results.

Log out

Always log out when you don't need to work in Bricsys 24/7 anymore. If you don't logout yourself, the system will log you out after one hour of inactivity for security reasons.

2. App Bar

On the left side of the Bricsys 24/7 screen, there is a vertical bar: the App Bar. In the App Bar, you can jump directly to the functionality you need. There are 12 different Apps, but you only see the Apps according to your access rights.

 **The Dashboard App** This is your central hub that monitors all your project related activities. It is subdivided in multiple sections:

1. Project details
2. Upcoming events
3. Recent documents (last 7 days)
4. Recent messages (last 7 days)
5. Tasks
 - Overdue tasks
 - Active tasks
6. Activity
 - All the recent project activity

 **The Structure App** This is a powerful document management tool. Here you find a comprehensive overview with the statuses and details of all objects in the project. This App is the core of the project and displays all project folders you have access to in a tree structure.

 **The Address book App** Allows you to manage all your project contacts. Contacts can be grouped together in organisations.

 **The Calendar App** Allows you to manage, track and lock all events and meetings.

 **The Report App** Allows you to review workflows by filtering on timeframe, workflow, folders and assigned actors for the tasks.

 **The Task App** Allows you to find all your tasks and filter them on metadata, folder and workflow.

 **The Messages App** Allows you to focus on clean project communications. Here you can send messages (mail) to other people in the project.

 **The Forums App** This is the place to discuss various subjects with other project participants.

 **The Links App** Allows you to share and view URL-links to external web pages.

 **The Workflow App** Allows you to design and edit workflows using an intuitive drag and drop editor.

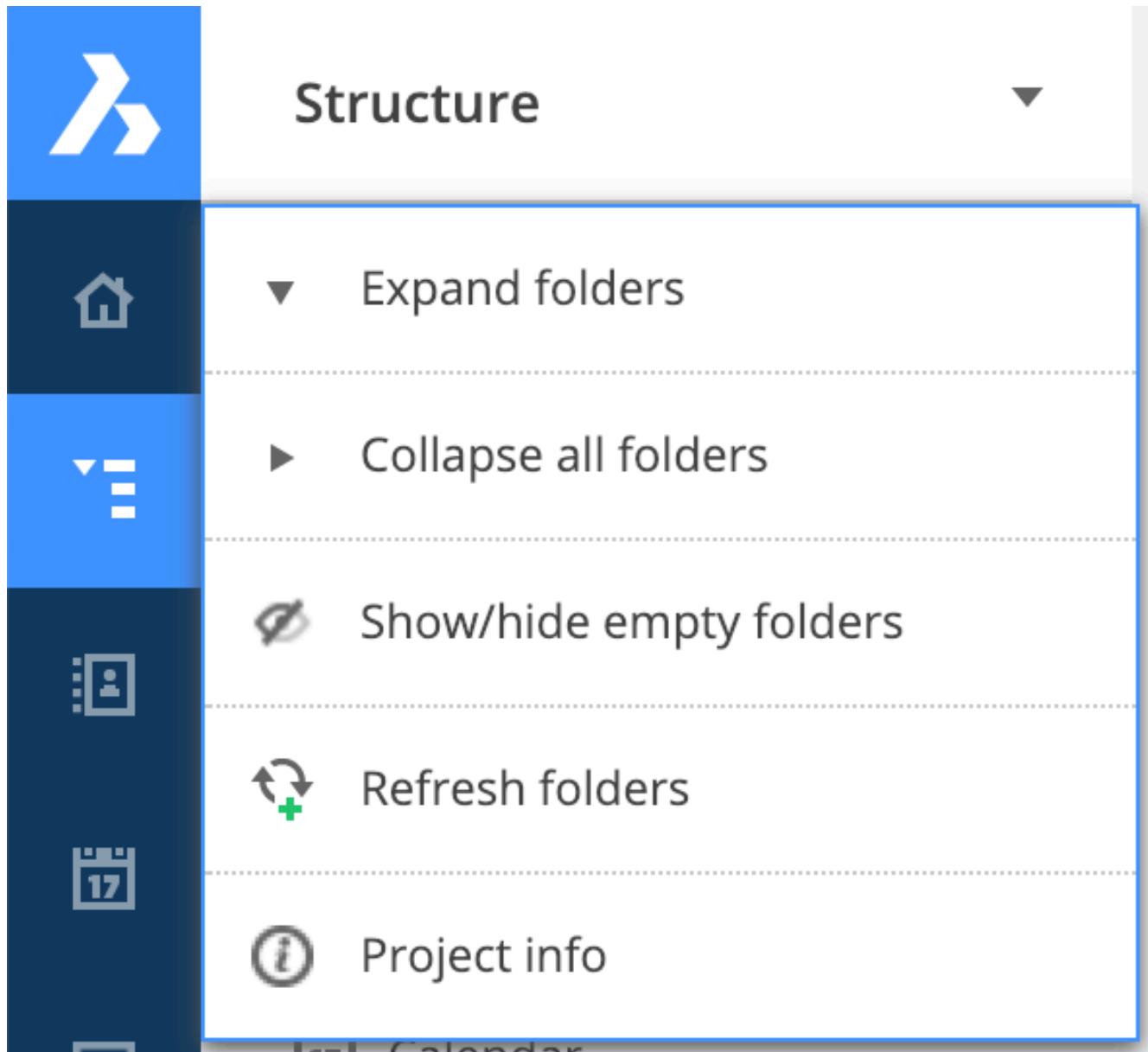
 **The Forms App** Allows you to build forms and store metadata using a simple drag and drop system.

 **Administration App** Allows you to manage the project (Only visible for Administrators)

3. App Menu

The App Menu shows the name of the App you selected (in the App Bar) and its related folders and options. Except for the dashboard App, all Apps have an App Menu. If you click on the arrow next to the App Name, a dropdown list with the App Menu actions will Appear. Some actions will be disabled if you have insufficient rights or if the actions are currently not possible for you. (2.26)

4. App Content

The objects in the selected folder are displayed here. Because there are different Apps (See [App Bar](#)), the App Content will adapt according to the selected App. On top of the App Content, you find Actions and a Views. Except for the Dashboard App all Apps will have an App Content with Actions and Views.

5. Actions

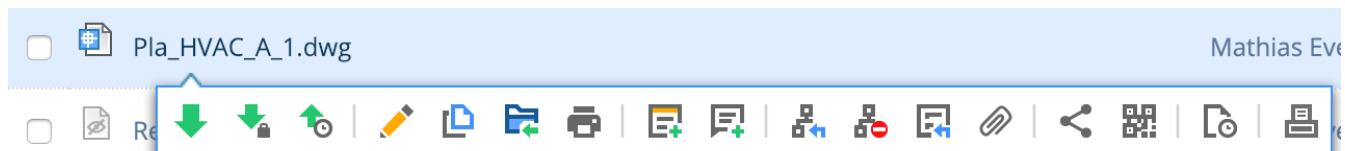
All the actions in the App Content are stored in two different bars. The actions in these menus adapt according to the App, access rights and/or the folders/objects you selected. You will only see the actions that are currently possible for you. According to the number of the selected objects, you can choose which bar you want to use. If you do not see all the actions that are explained in the different Apps, it means you have insufficient rights for these actions (See [Introducing Bricsys 24/7](#)). To see which rights you have, see the folder information action in [Views](#).

- Actions on a single object

Actions on top of the App Content Click the checkbox of the object and select an action.

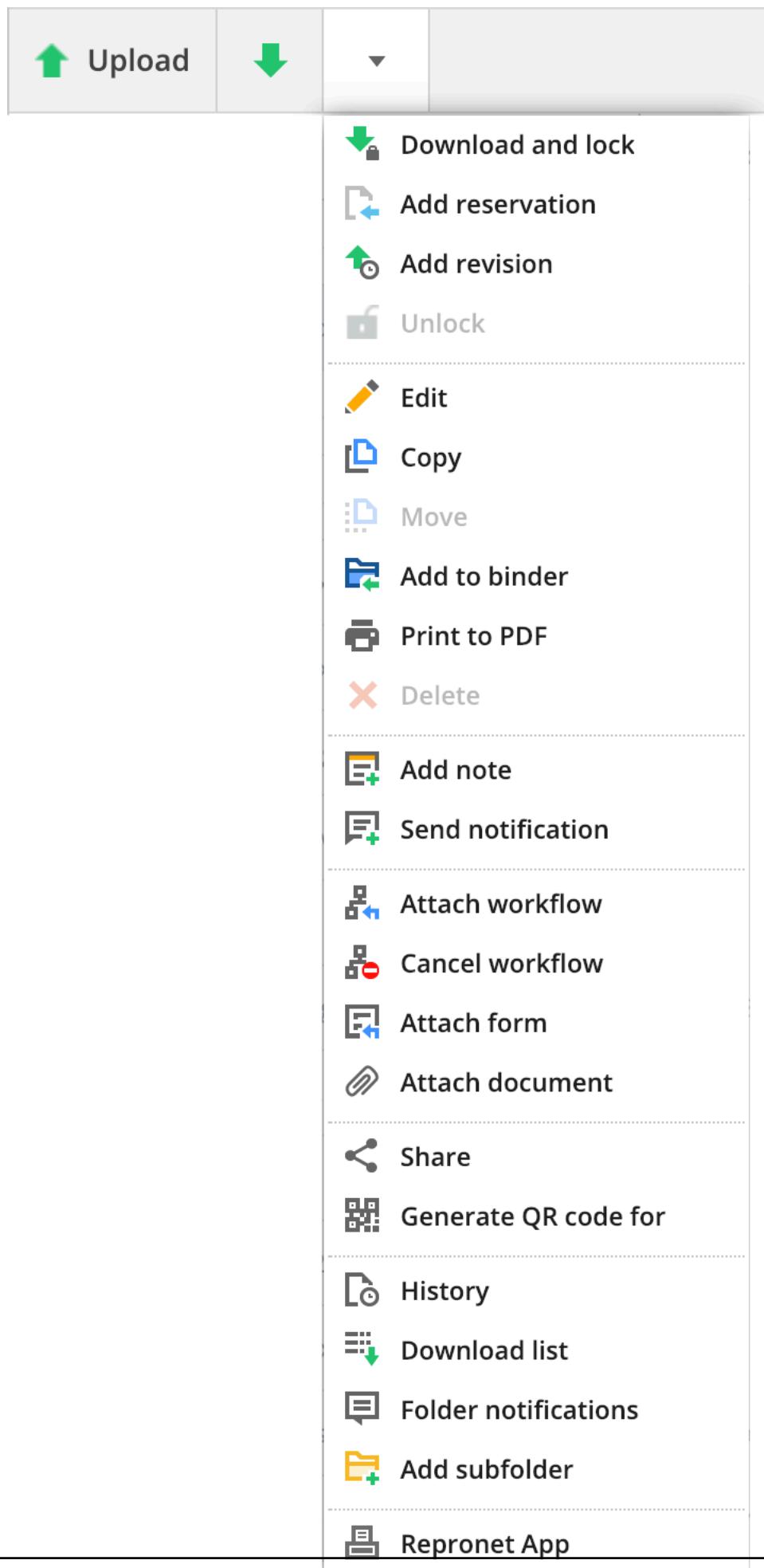

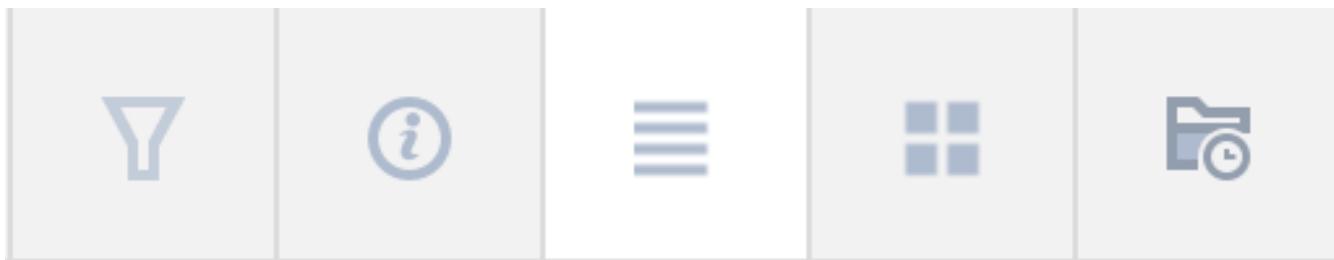

Name When creating a new relation, you need to define the name of your highest level. That's the relation name users will always see first. The root element of the tree. When using a relation field in a metadata form, the name will be used to generate the document name.

Description Additionally, you can add a description to describe in more detail what it's about. This comes in very handy when you work with coded values like "BA, Building A" where "BA" is the actual name and "Building A" the description.

CSV In case you already have the structure defined in a spreadsheet, you can easily upload the structure to Bricsys 24/7 by exporting it to a CSV file.

UTF-8 encoding Be aware that the system will process your data in UTF-8 format. Make sure when exporting your CSV that UTF-8 is the chosen encoding. If you see strange characters in your relation after you uploaded the CSV, your encoding is probably not set correctly.

Format In order for the system to correctly create your relation you need to follow a simple set of rules:

- Each line can only have one new level
- After each new level, you can add a description (not required)
- The highest level may or may not be defined

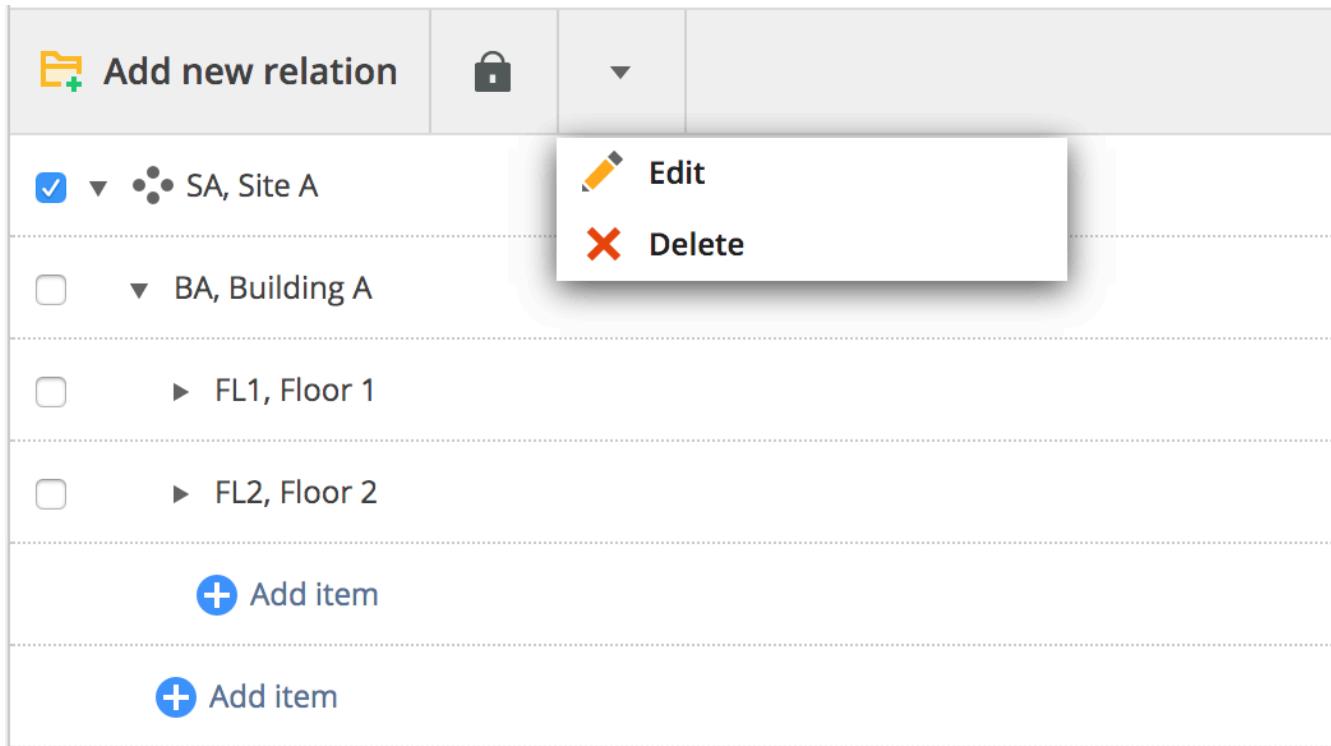

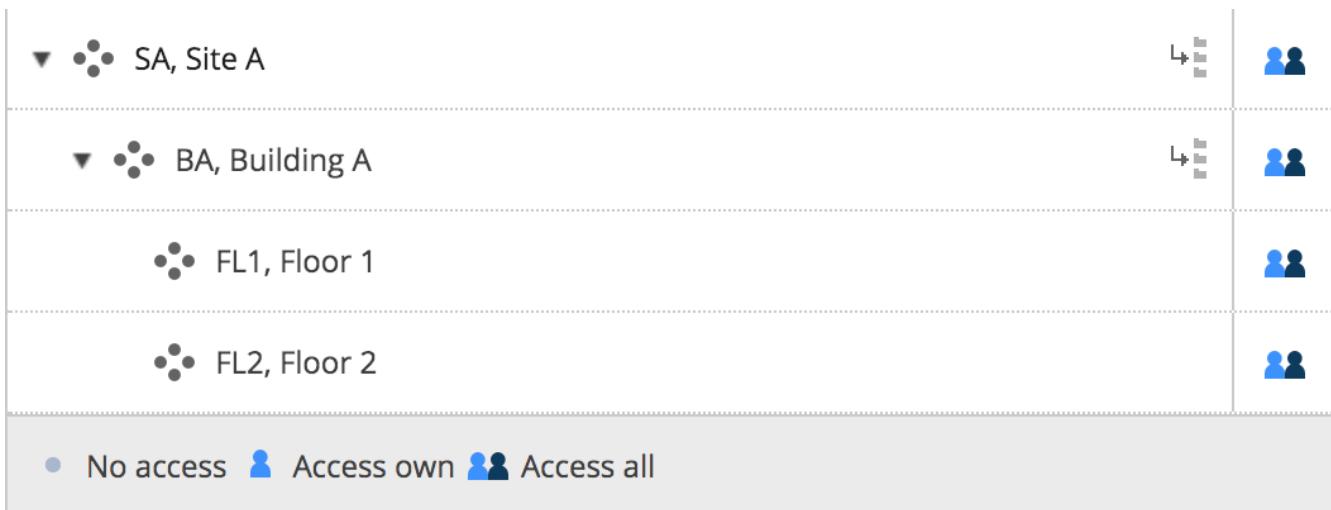

Different ways to use a binder:

- 1. Group different types of objects** A binder can be used to group different kinds of objects that are spread all over the project, for example, to prepare a meeting.
- 2. Give a group of users access rights to a few objects** A binder can be used to give a group of users access to a few documents. If you give these users (via a roll) access to the binder, they do not need to have access to the original object in the containing folder itself.
- 3. Access to documents with a certain status** The administrator can edit the binder settings and enable that only certain document statuses are shown in the binder. This way you can give users access to a binder which contains multiple documents but only when the status of the document matches the filter on the binder, the document will appear.

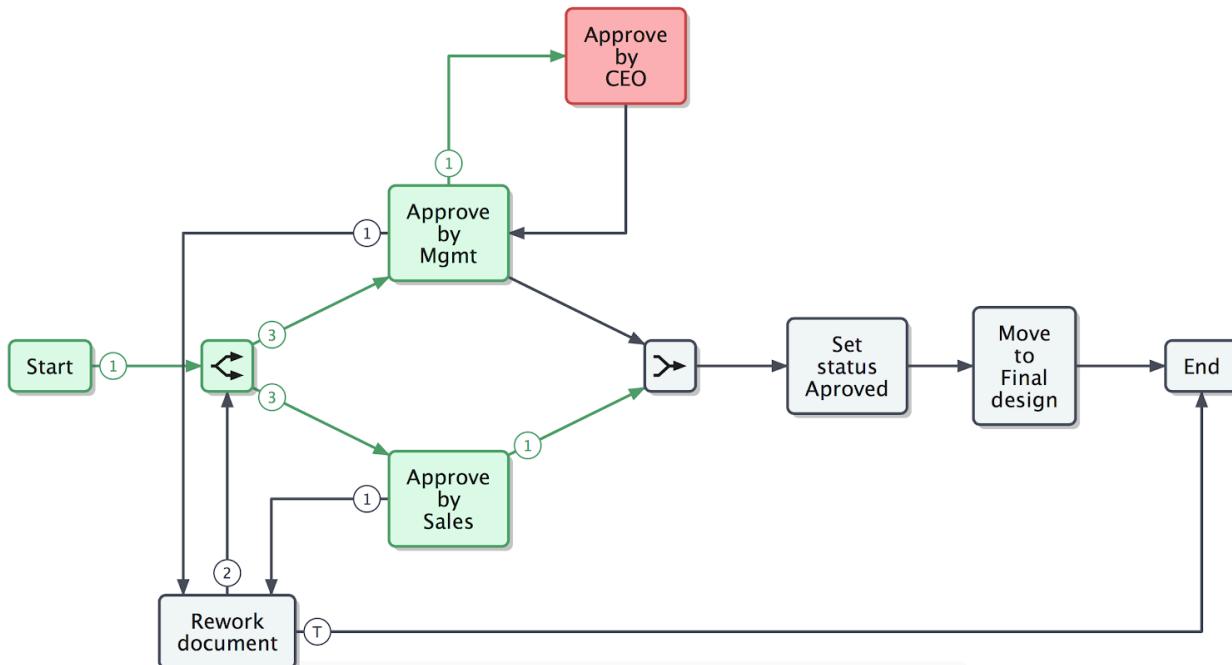

1. Advanced search Search in the advanced search on the filled in forms to find a document. For example: Search for all electrical plan on the third floor without knowing where exactly the plan is stored on Bricsys 24/7, you can easily find it.

2. Filter on metadata Metadata is visible in the document folder using the column selector. Use the filter button to search for Plans by filling in 'Pla' (for example).

3. Automatically generate a name Optionally generate a name for the document based on the filled in form. This gives your documents a structured name following the naming convention for your project. All documents will be named correctly according to your naming convention.

4. Create reservations Create reservations for documents to be uploaded. When metadata is used to generate a name, you are able to create reservations which are empty documents to be filled in by the user. An extremely useful tool in your document planning. Make sure all desired documents, plans are delivered.

Attachment

Instead of adding a note to a document, a user could attach a form (with pre-structured information) to a document to give a comment in a structured way. Once the user filled in the form a record of the form will be created and attached to the document.

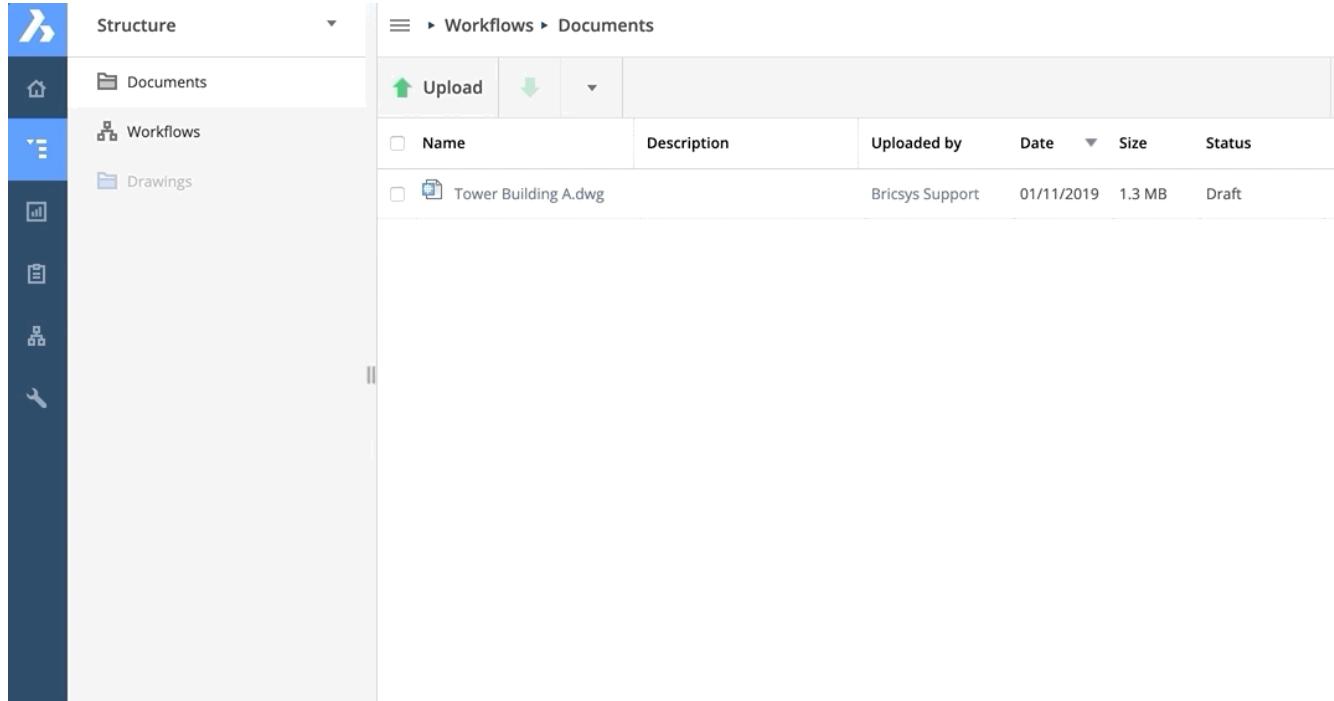

Forms are a great tool to save all kinds of data in Bricsys 24/7. One of the most common use cases is metadata, extra information to a document in order to easily group documents together and search on that data throughout the project. Follow the next steps to successfully create and manage forms in your project.

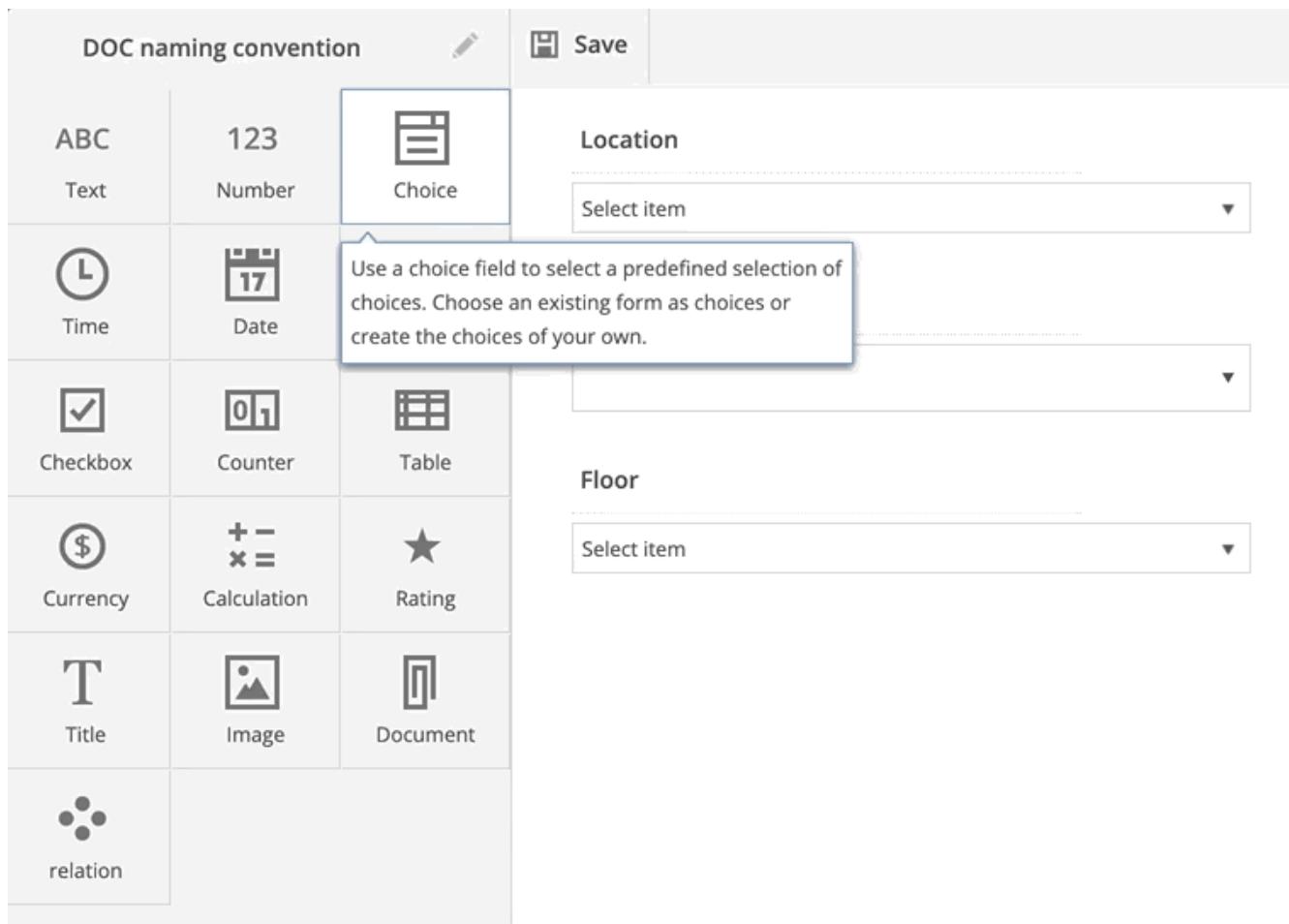

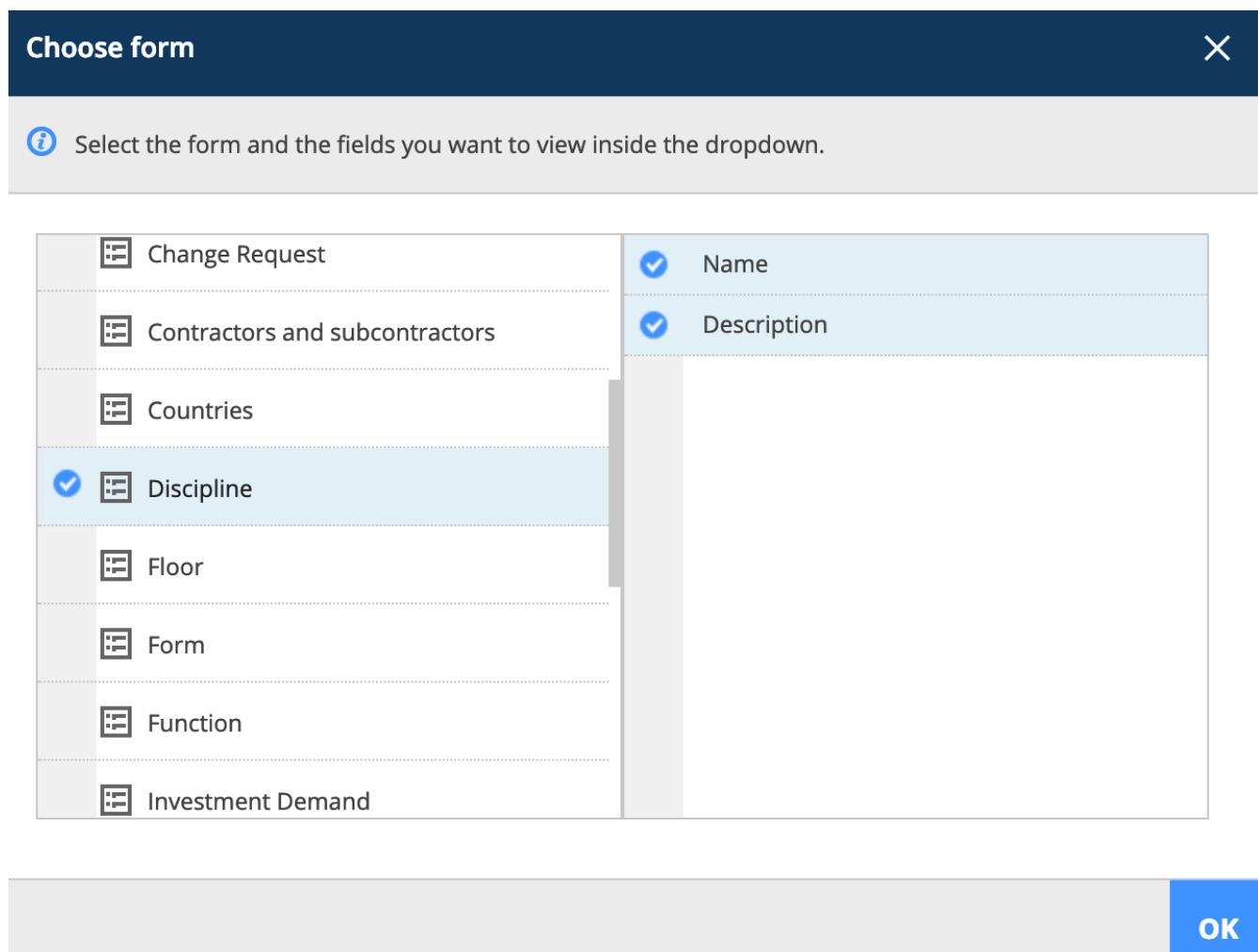

Rename uploaded documents You can rename documents based on the data filled into the form. This is ideal for everyone looking to have a structured name for their documents. Renaming also enables you to [add reservations](#). The administrator can also define default metadata per folder so a user doesn't have to pick all the values each time a new document gets uploaded. Default values You can predefine per folder metadata values. This lets you set values so a user doesn't have to select it again and only needs to fill in the necessary metadata.

Reservations

It's not uncommon that document managers already have an entire list of documents to be produced for the project. With reservations you can add empty documents that are a placeholder for the real document. In order to work with reservations, the attached form needs to have the "[Rename uploaded documents based on the field's content](#)" option checked. Open the document folder and select the "Add reservation" action from the menu. You can add up to 50 reservations at once. In the example below we are adding 3 reservations: ([2.97 on the following page](#)) This results in 3 reservations: ([2.98 on the next page](#)) The real document can be added as a revision which will replace the placeholder. Add Synchronize Parallel Path If you want 2 or more paths to come together, add a synchronize path. The synchronize path will wait for all incoming transitions to be activated before continuing the workflow. For example If both contractor and engineer approve the document, continue the workflow and set the status approved.

(d)  **Move / Edit your workflow (optional).**

Move the activities to the correct position to have a better overview of your workflow.

i.  **Add transitions**

Transitions are the arrows that connect activities and make it possible for the workflow to follow a predefined path. Outgoing transitions from manual activities are the answers that a user can select when executing the task. An outgoing transition can have multiple answers. In Bricsys 24/7 we refer to answers as states. [\(2.111 on page 114\)](#)

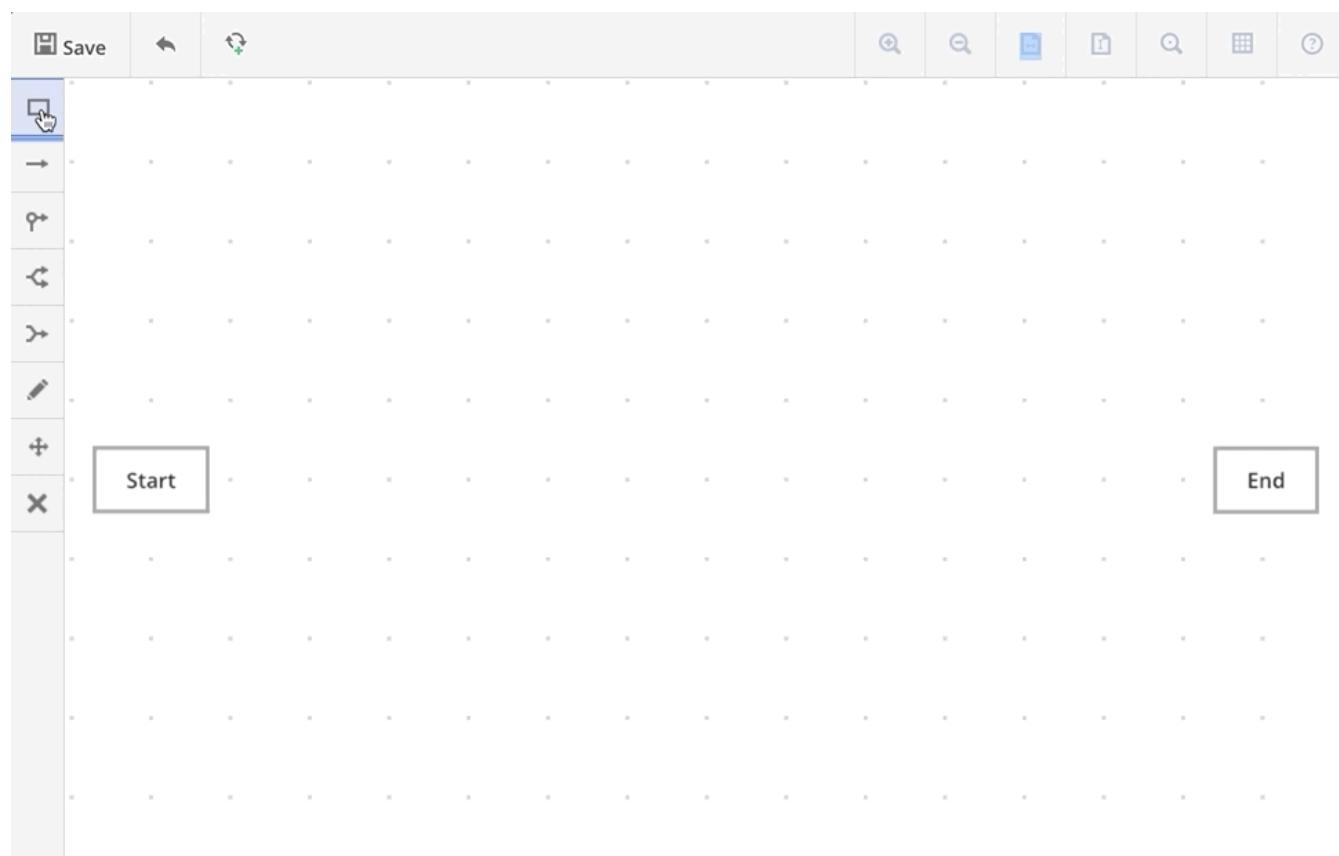

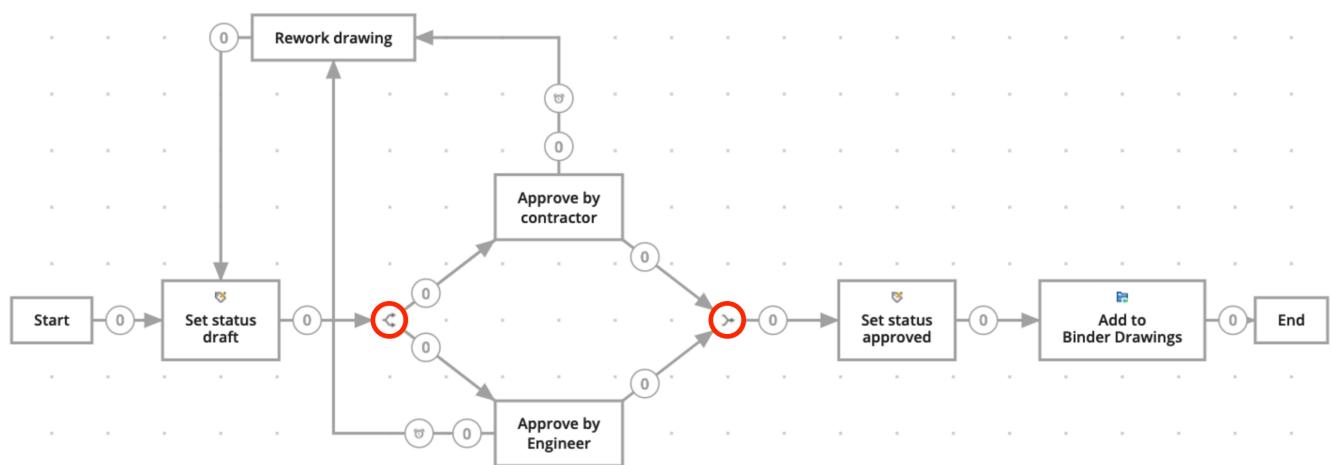
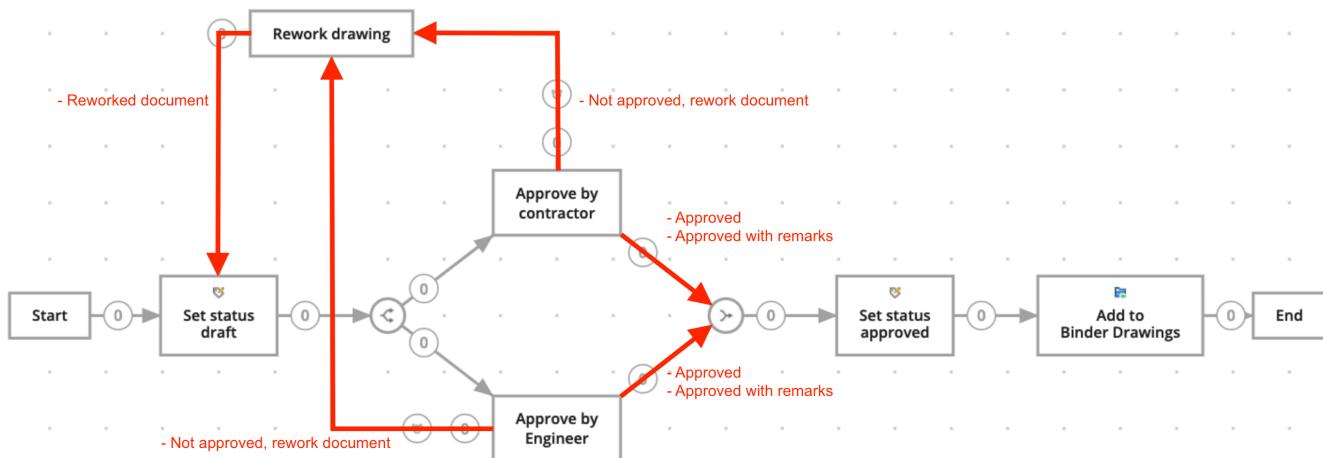

Create a transition from one to another activity

- Click the activity the transaction has to start from.
- Click the activity the transition has to go to.

Transition settings (2.112 on the next page) Every transition needs at least one status. The system will automatically create put "Done" as the default status.

- Add one status (for manual tasks only)
 - If you're adding a status to a transition, the actor of the activity has to respond to the activity before the workflow will continue. The status that is filled in the transition will be the proposed answer for the actor. When the actor selects this proposed answer the workflow will continue.

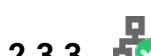

- If you selected that the actor of the task has to act within a certain time, you can mark the transition to be followed once the deadline has passed.
 - For example if the actor doesn't react within 2 weeks, the workflow will continue to the next action via this transition.

Transition states need to be unique. There cannot be two outgoing transitions that have the same state. Eg. The answer "Approved" and another transition with the same answer "Approved". This would make it impossible for the workflow to choose the correct path.

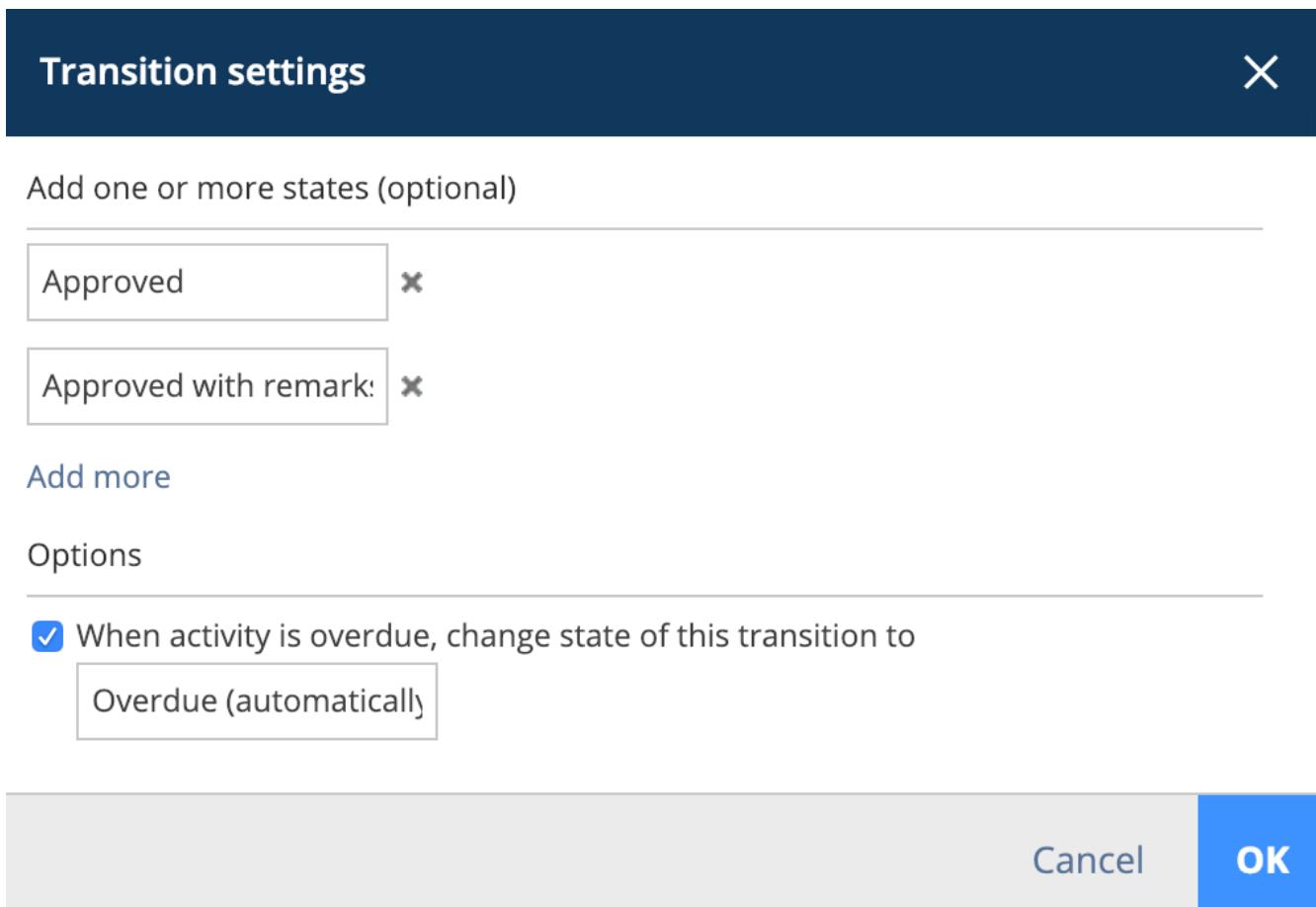
After you created all your activities and transitions, do not forget to save your workflow in the workflow editor before you close the editor.

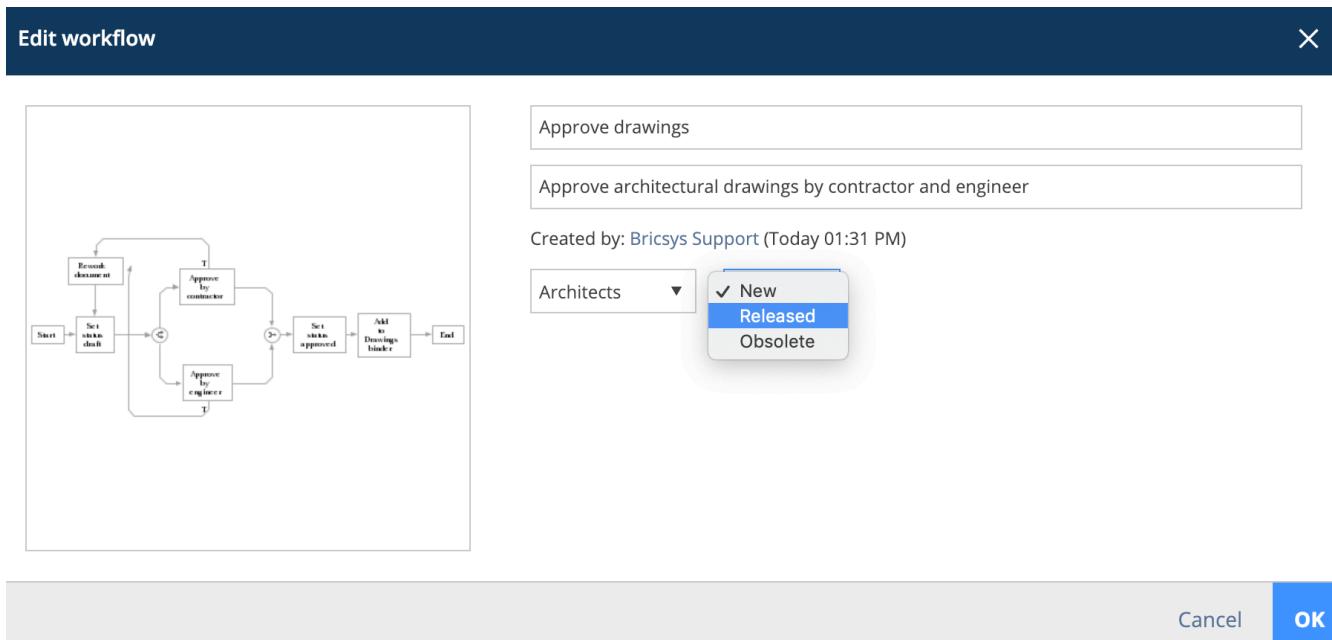

2.3.4 Attach workflow

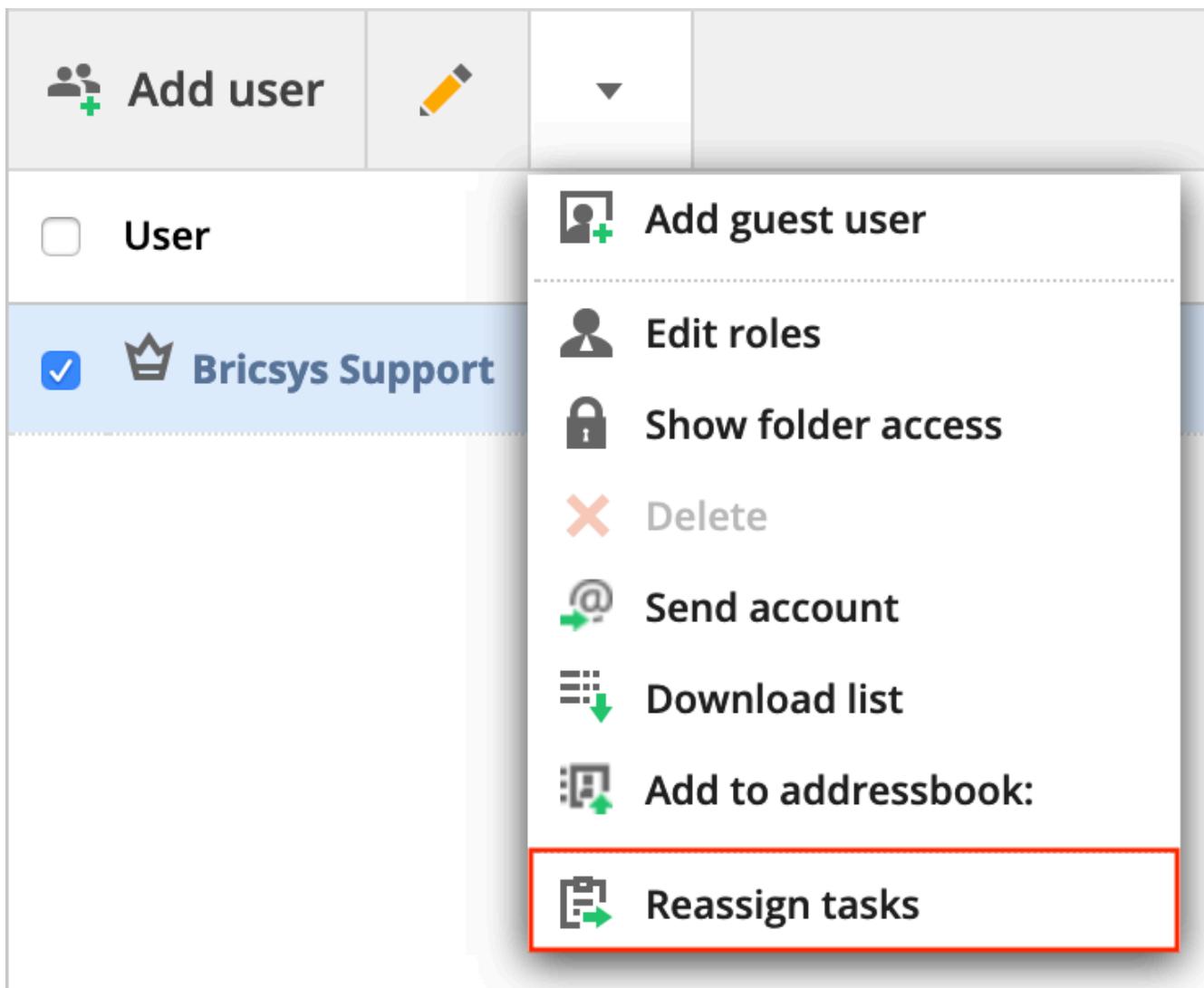
Once the workflow is attached to the document it will start automatically. Note that only workflows that are released can be attached.

Attach a workflow to a folder If you want to automate all the documents in a folder with a workflow you need to attach the workflow to the folder. (See [Administration App > structure](#)) Once the workflow is attached to the folder, it will start for every new document that is uploaded.

Reassign task

It happens all the time, a project member got sick, is on leave or left the company but still has tasks assigned to be executed. As an administrator you can easily reassign tasks of a user in Administration > Users. Select the user and choose the "reassign tasks" action from menu above. Select another user in the project to transfer the tasks too. Note that the user needs to be in exactly the same roles as the current user assigned to the tasks. ([2.114 on the next page](#))

Cancel / delete workflow

It is possible to either cancel or delete a workflow. If you cancel it you will basically put it on hold and it can will be possible to activate it again if needed. However, if you delete it, it will be transferred to the recycle bin. 1. To cancel a workflow: As coordinator or admin: you need "view" access to the document. As owner: you need "edit" access to the document. You will find the "Cancel" option in the drop down menu of a document that the workflow is attached to. Since cancelling is related to editing rights, please note that the "cancel" option is not associated with adding rights. ([2.115 on the following page](#)) 2. To delete a workflow: There may be no instances attached to the workflow and you will need deleting rights to the document in order to be able to delete the workflow. As long as you have the appropriate rights you can delete the workflow by clicking on "Delete" in the drop down menu of the workflow. ([2.116 on the next page](#))

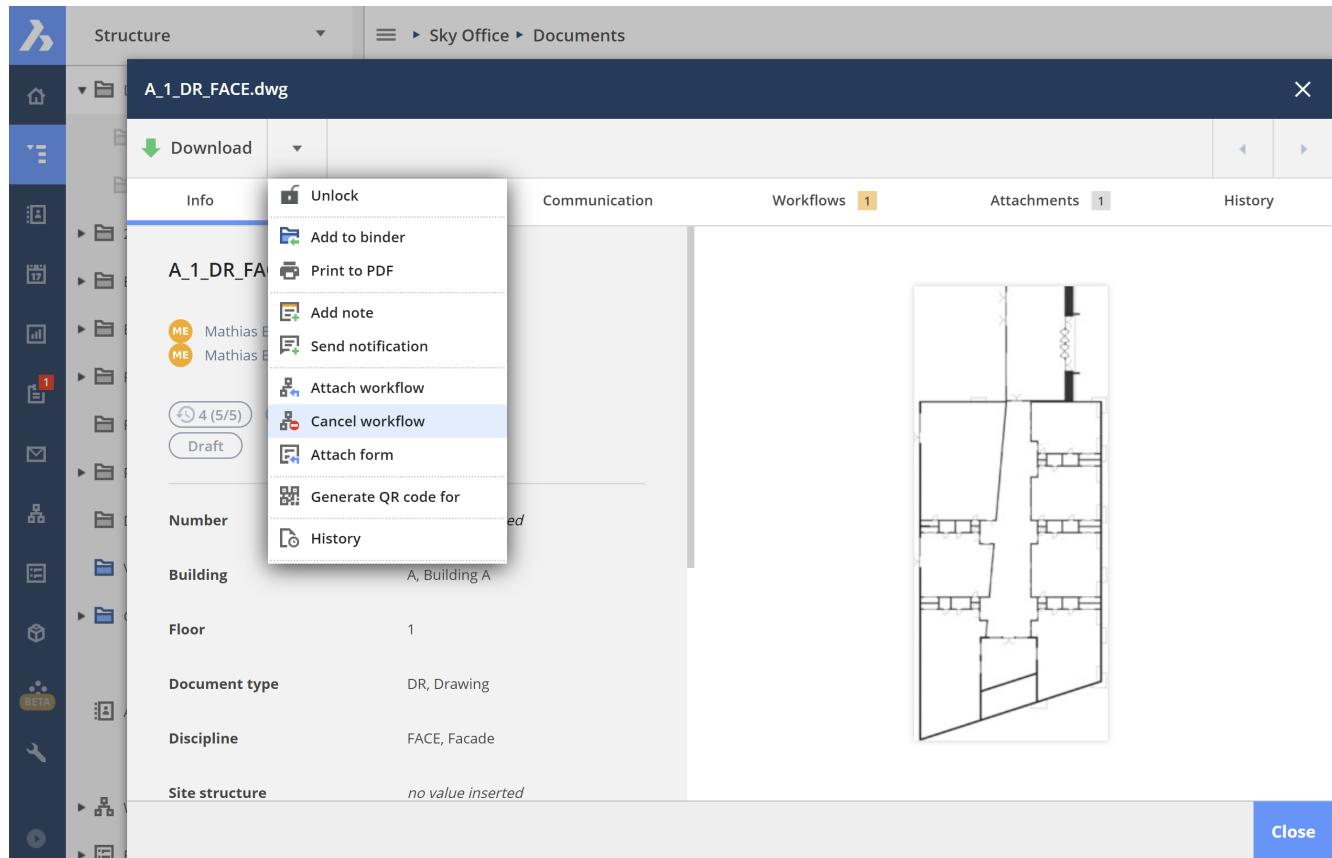
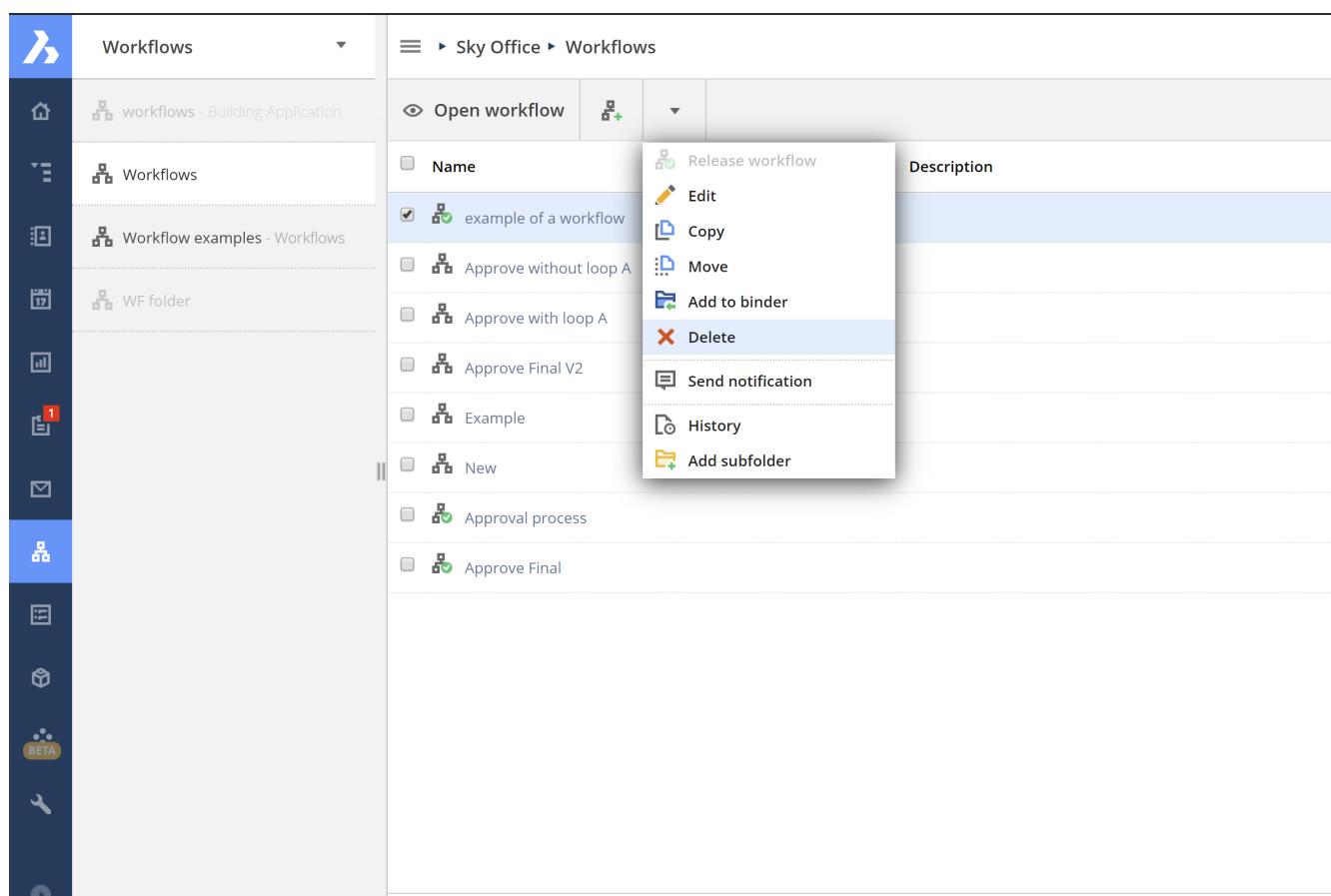


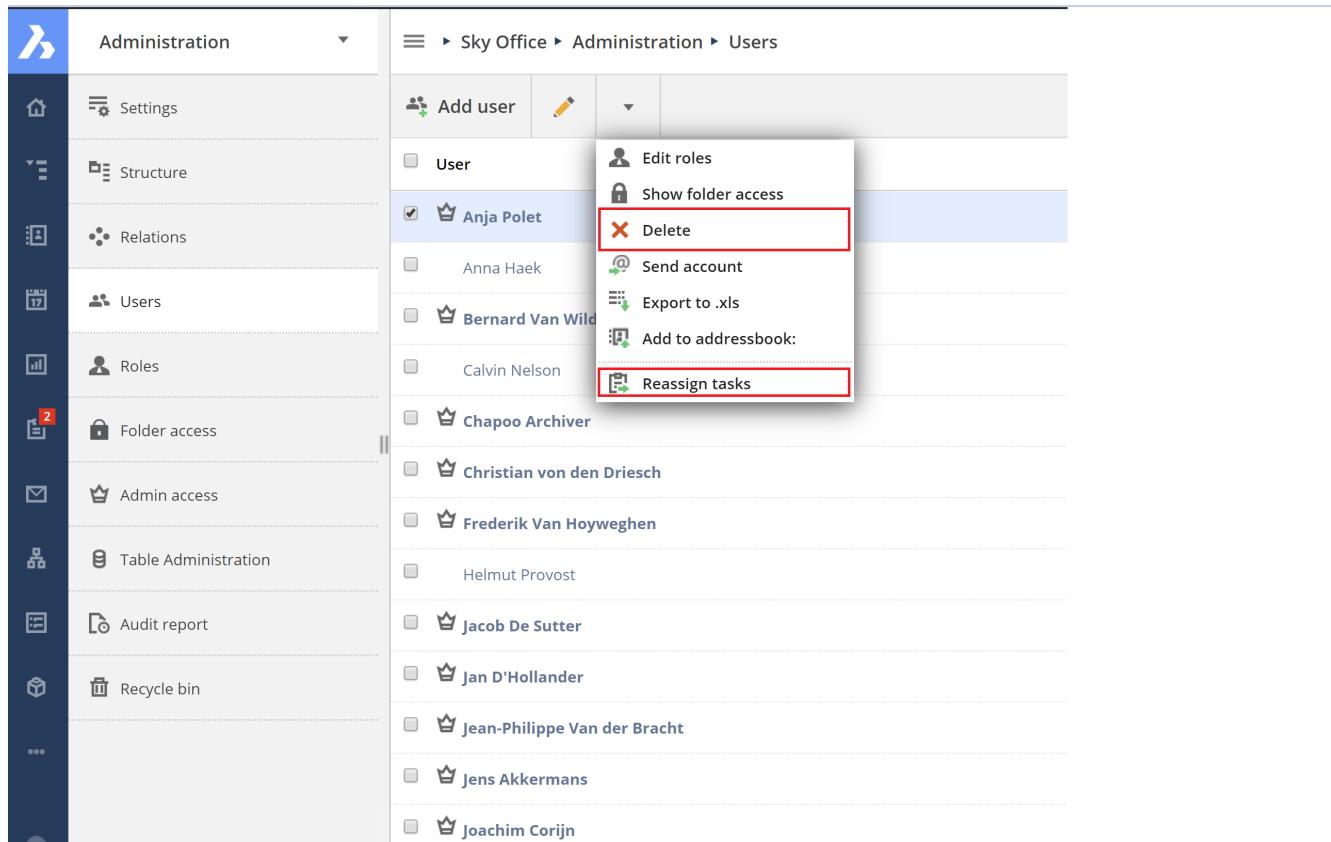

Delete user

In order to delete a user from a workflow first, you will need to reassign all tasks to another user who has at least the same role membership. Anyone who is in role 'administrator' can forward all tasks of that user to someone else. Only then it will be possible to delete the user. Once the coordinator is removed anyone can become a coordinator, as long as he has the same access rights. It is up to the administrator to choose a new coordinator. (2.117)

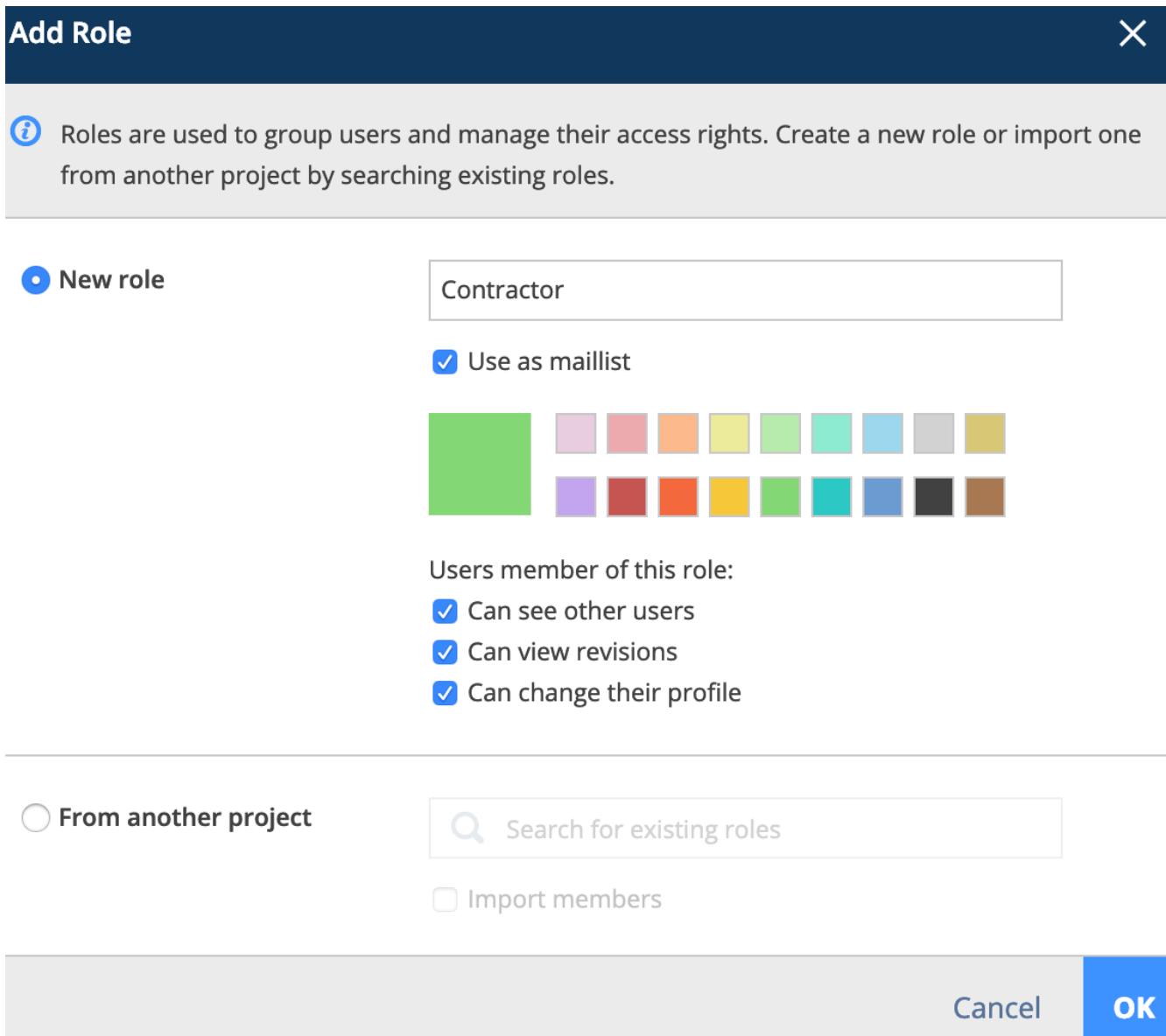

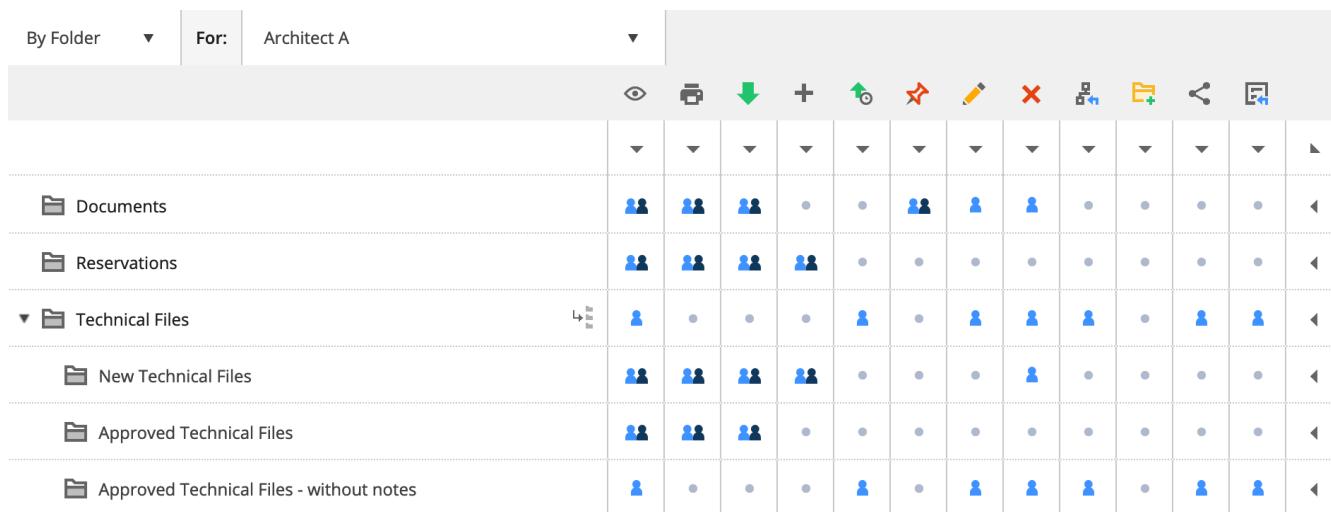

Folder Access

Once the folders and the roles have been set up, it's time to setup the access. The Folder Access category by default shows the folder structure and a role in the dropdown above the structure. Easily switch to roles view by selecting the "By Role" option in the dropdown above.

Access inspector The access inspector on the right shows you if the access is set or not. There are two types of access: view all, view own. View own means that the user can only access the items that he or she is author of. Depending on the type of folder, not all access types might be available. Click in the matrix to set or remove a specific access. Use the toggle buttons on top to set the same access over all the folders, the toggle buttons on the right to set default access. The top right corner toggle button allows you to toggle all the access. For each folder with subfolders the "apply to subfolder" icon lets you easily copy the same access to all the subfolders. 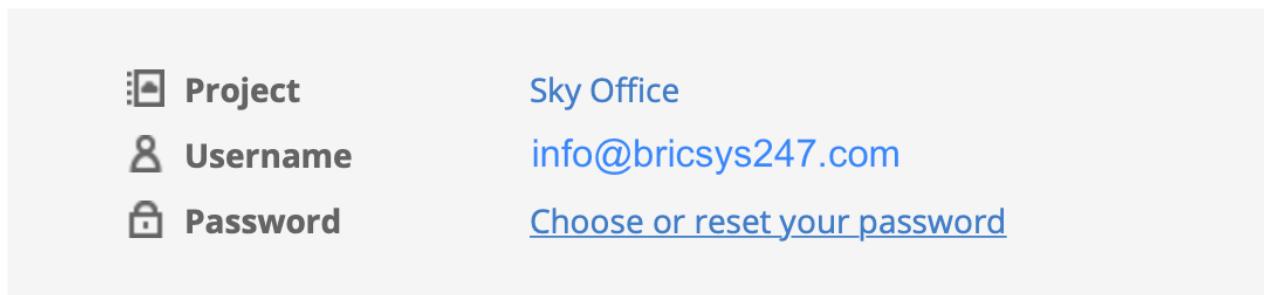
Users

Now that a project has folders, roles and access we can add users. The Users category lets you add users to the project. Click the Add user action to add a user. Always add users by adding the **email address** of the user. In case the user has already access to Bricsys 24/7 in another project, the user will be shown in the search results. Otherwise you can create a new user. After adding the user, select the roles the user is part of. A user can be part of multiple roles which means the access will be the consolidated access over all the roles. If the project has an address book folder you can choose to add the user to the address book.

Invitation The last step is to send an invitation. We highly recommend to add a personal message so the user knows who's sending the invitation and the reason why. The user can setup the password by clicking the "set or reset password" link in the invitation email. An existing user can login with the email address and the existing password. Settings

Fill in or edit the basic information of the Project, ask for support and change project settings.

Structure

Add or edit the project structure (project tree).

Relations

Add or edit relation structures.

Users

Invite users and assign them to their corresponding roles.

Roles

View, add or edit roles and their specifications.

Folder access

View, add or edit access rights to roles for folders.

Admin access

Specify to which sections an administrator has access.

Table administration

Change access rights for forms.

Audit report

Search through every Action / Object / User in the activity log of the project.

Recycle bin

Restore deleted objects / folders /... from the recycle bin to your project or decide to delete them definitely.

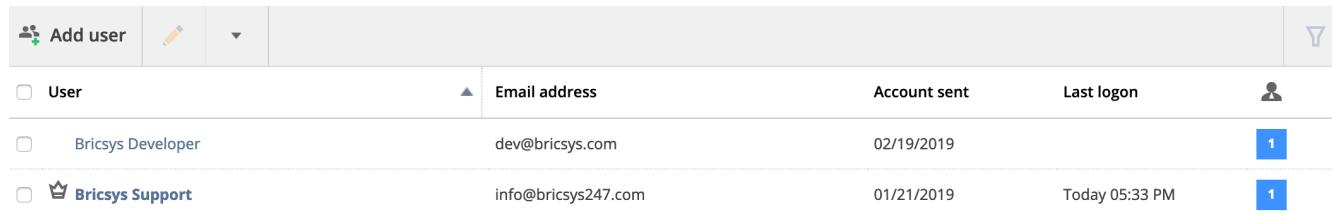

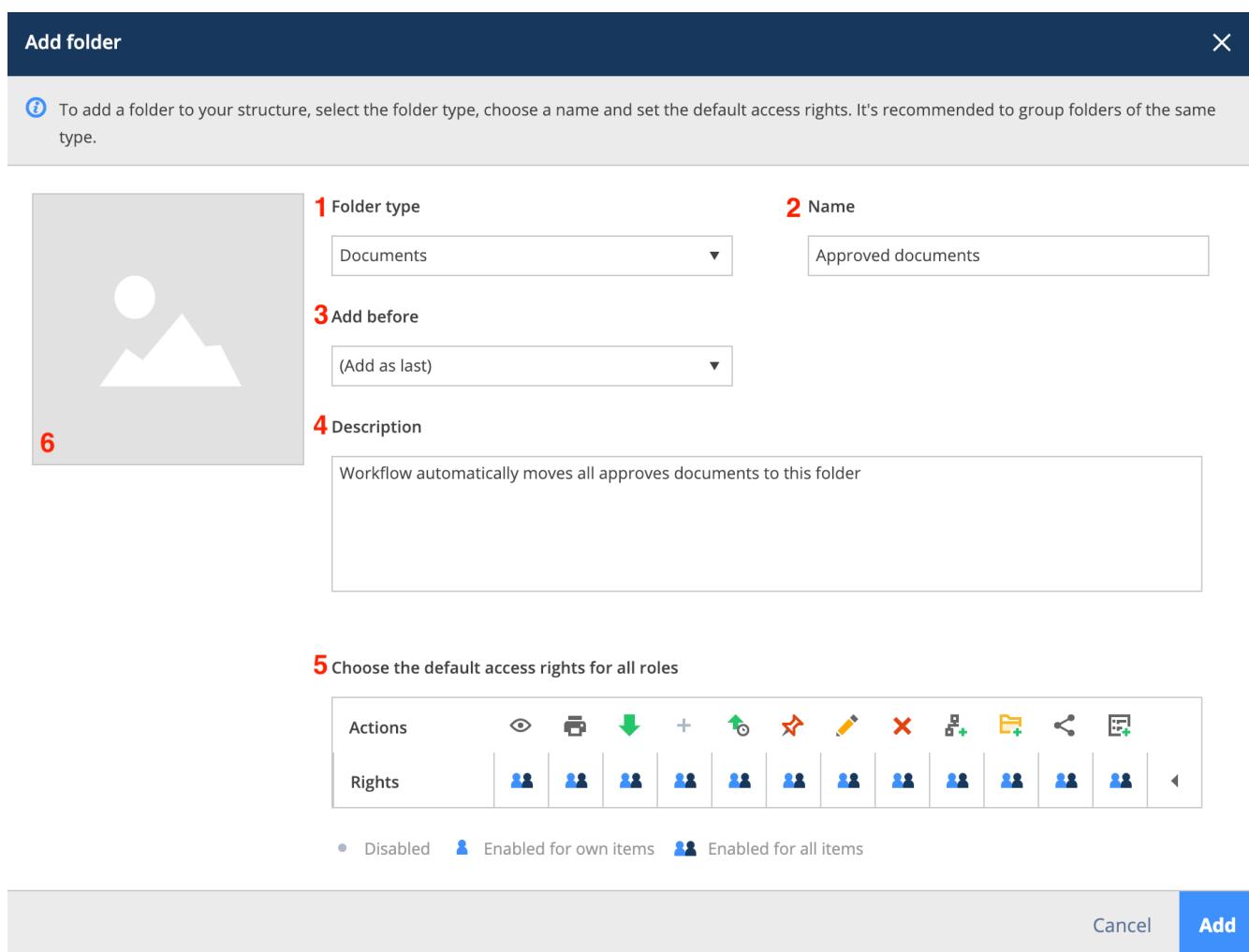

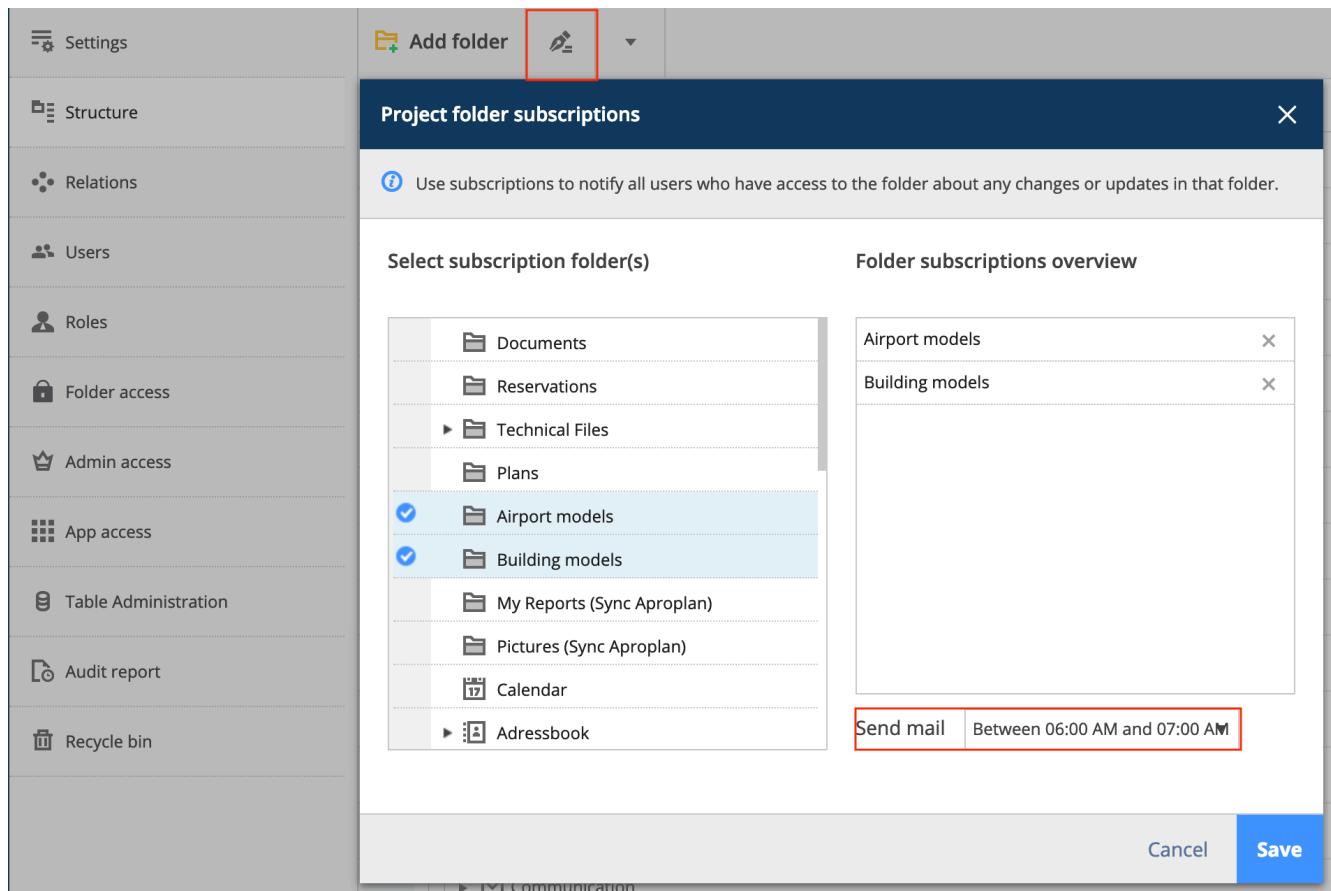

If there are no more (or more) document fields in the form, you can choose with this new option at which level the metadata will be stored. There should not be any changes to existing links between forms and folders and the reading of the data will remain as it used to be. 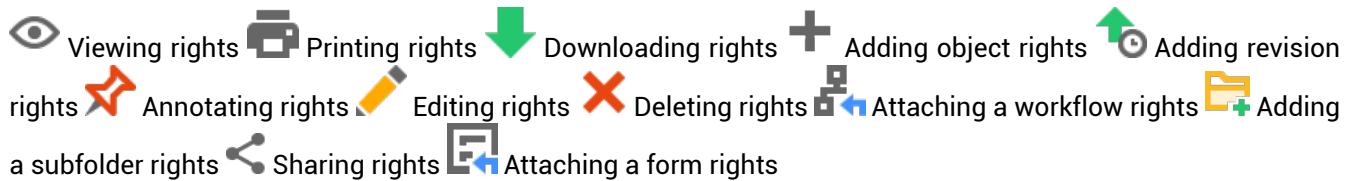

- Members of this role can view revisions
- Members of this role can change their profile
 - The members can change everything in their profile: profile picture, email, password, folder subscriptions...

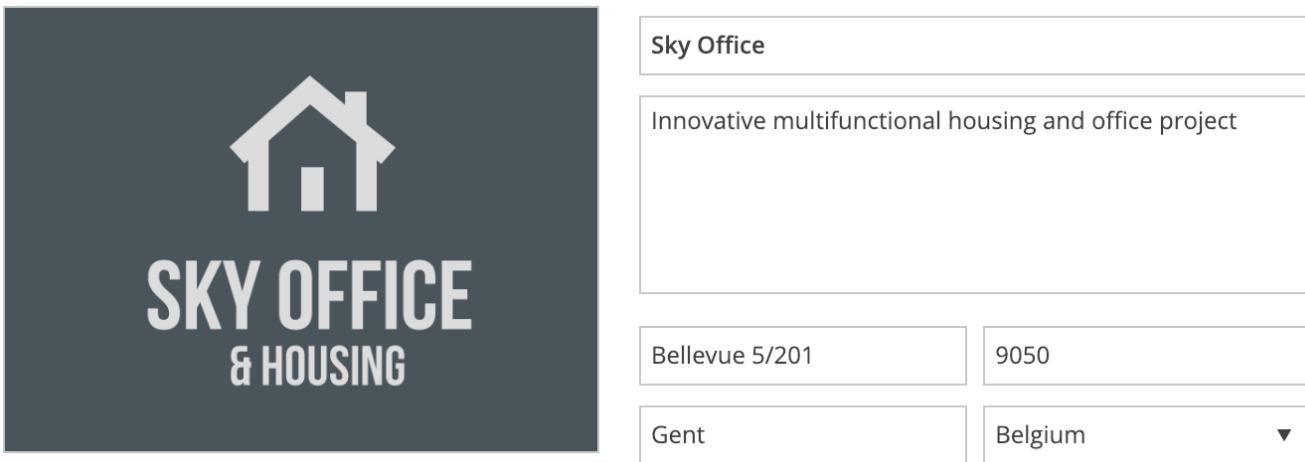
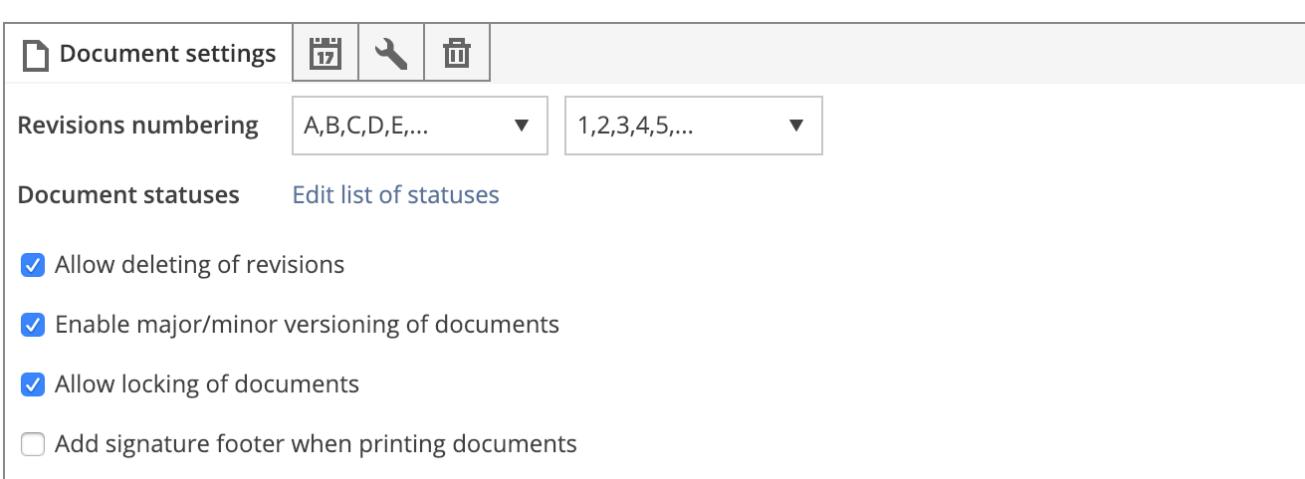

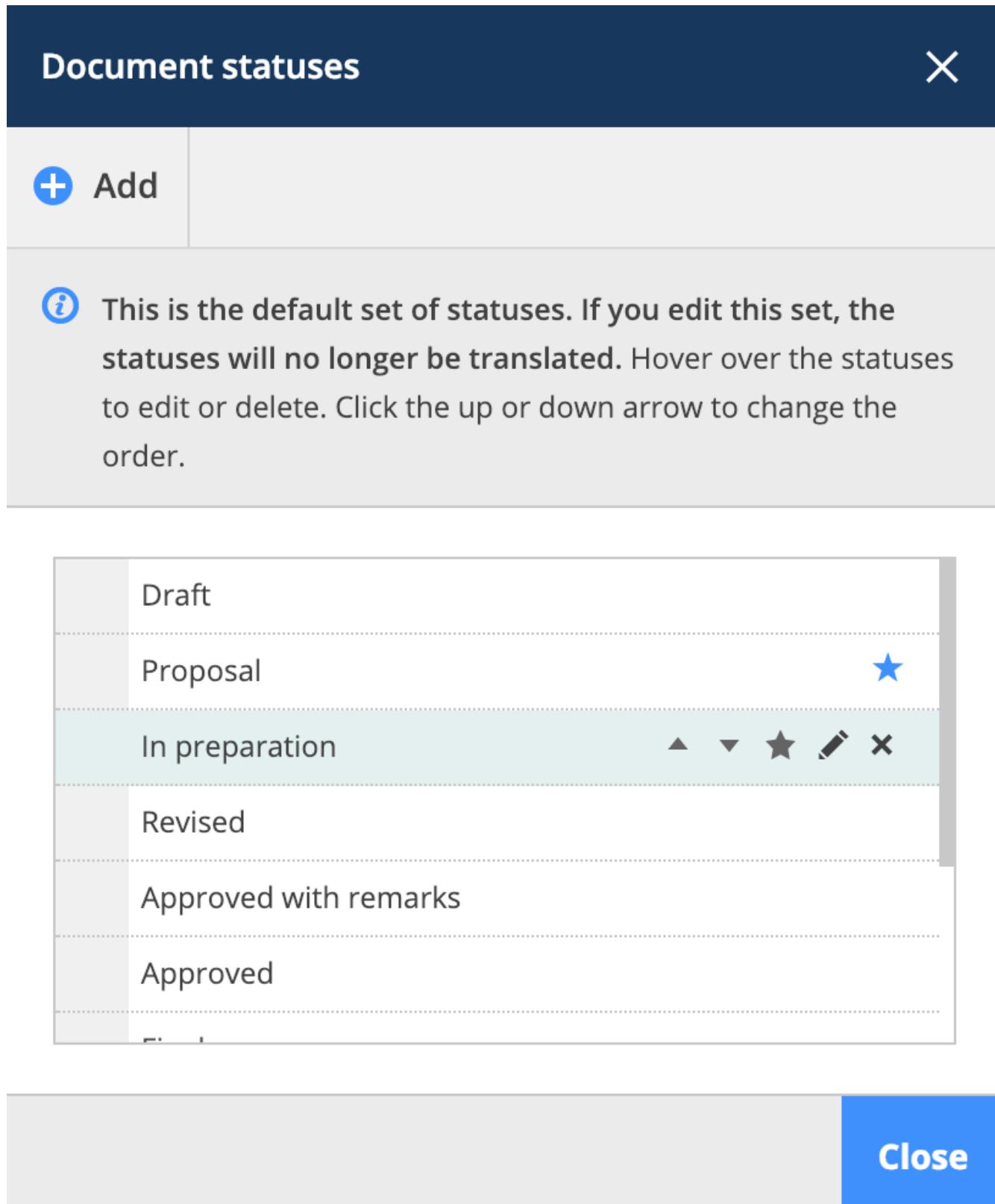

The one of the left is the major version and the one on the right is the minor version. The setting you see in this example will generate document revisions like this:

- A.1
- A.2
- A.3
- B.1

Edit document statuses (2.146 on the next page) Bricsys 24/7 comes with multiple predefined statuses that are translated automatically to the user's language. However it is possible to add new statuses, edit the existing ones and make a status a default status. The order of the statuses in this list is how they will be shown in the dropdown when uploading a new document.

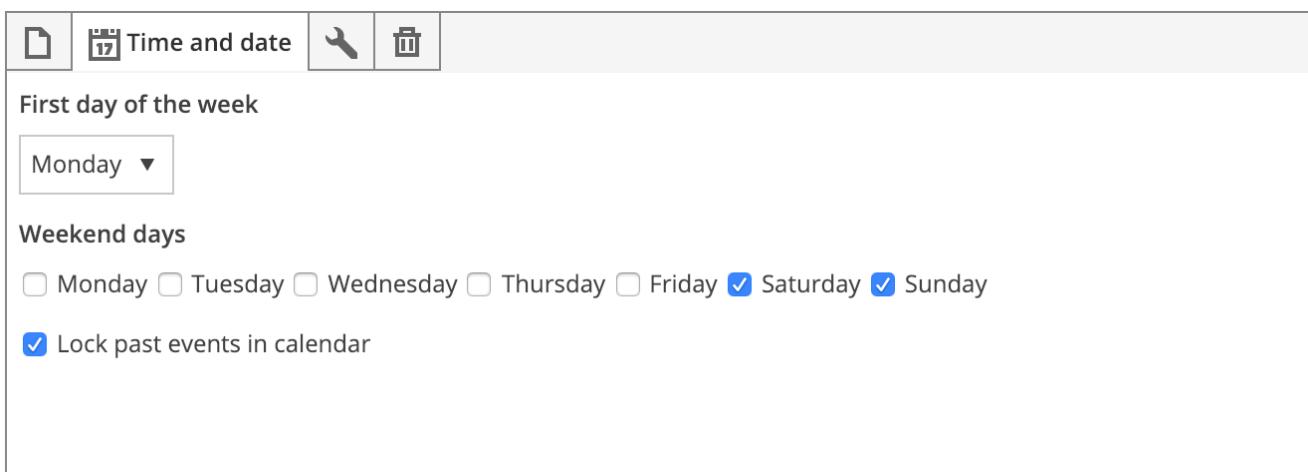

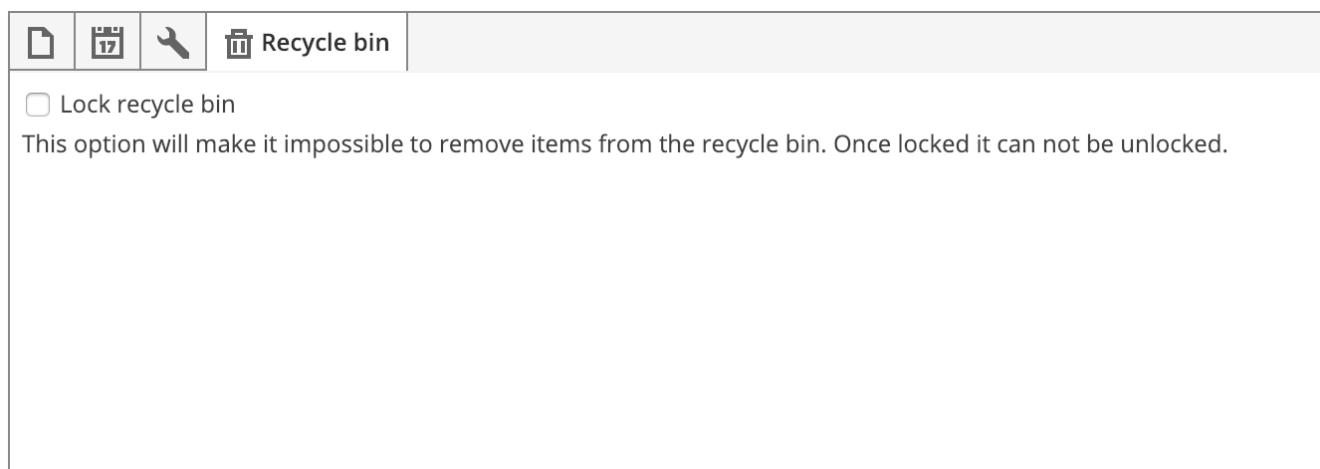

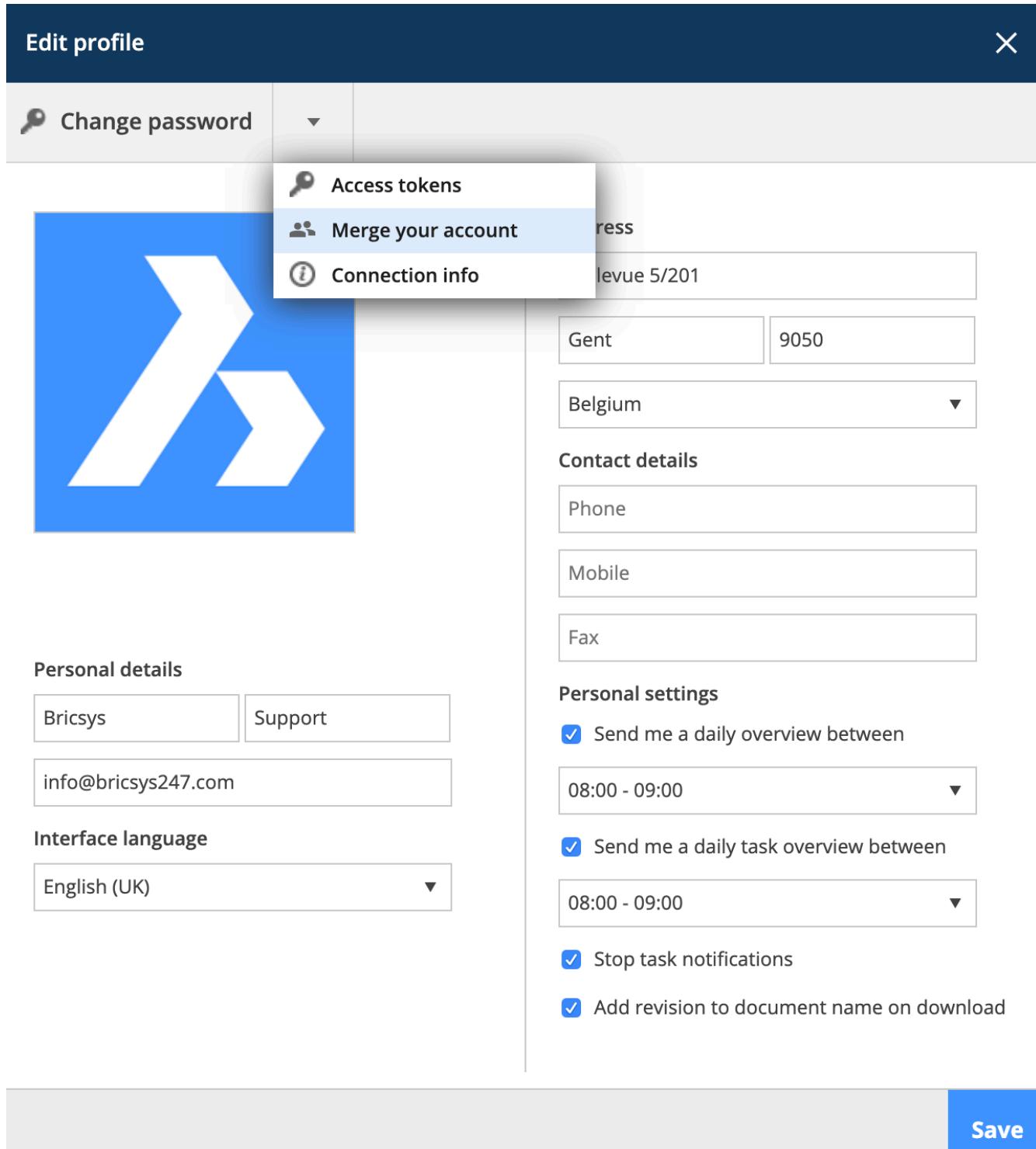

2.5.1 I have multiple accounts, can I merge them together?

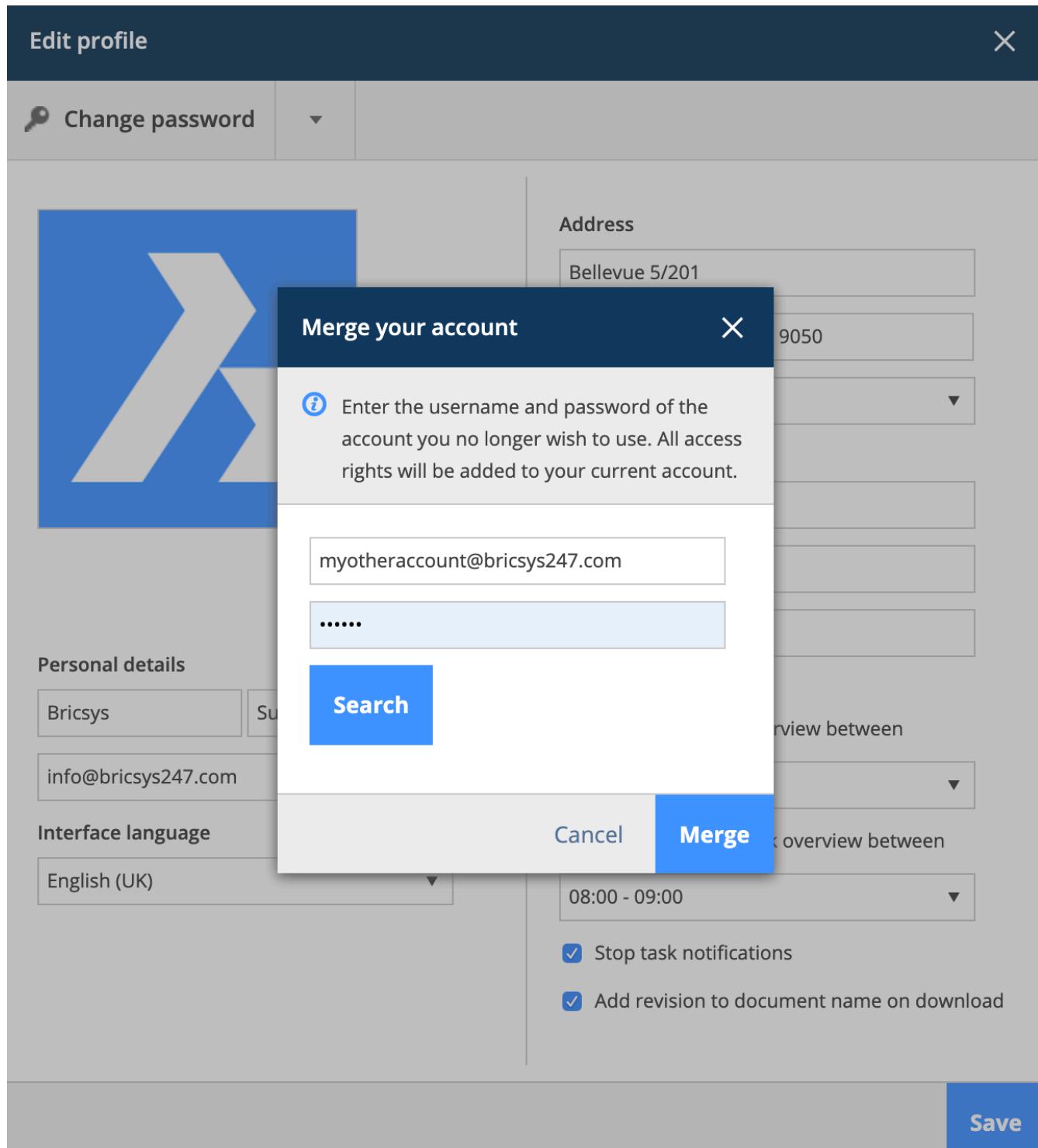
In Bricsys 24/7 it's possible to merge multiple accounts by opening your [profile dialog](#) and choosing the "merge your account" action. (2.154) A new dialog will ask you to fill in the username and password of the other account.

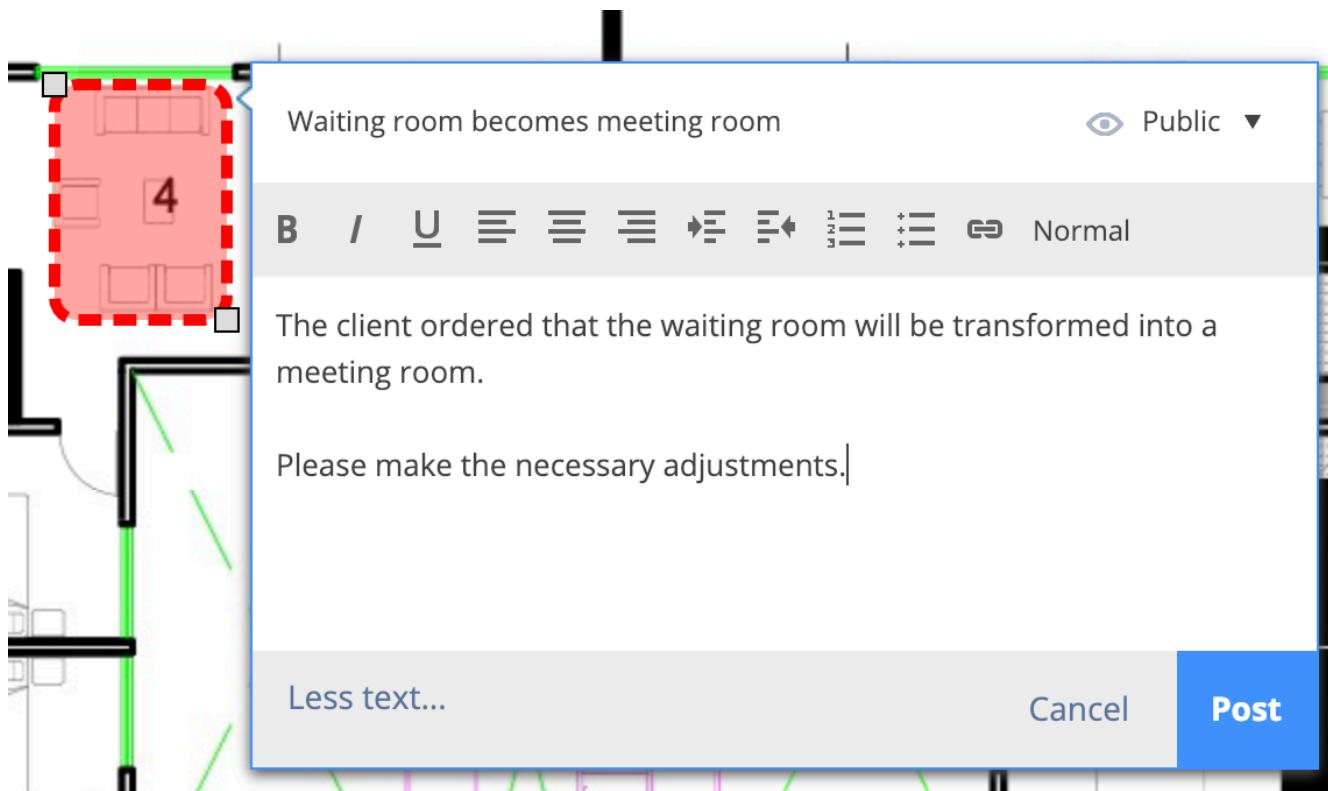

2.5.2 Is it possible to delete an annotation, a notification or a note ?

Annotations on Bricsys 24/7 are a great tool to comment on a specific area of the document. Notifications work in a similar way to emails and document notes look similar to sticky notes. All together they remain visible over all the revisions of a document and all of them are revision based which means that you cannot see the annotations, notifications or notes of previous revisions while viewing the latest version of the document. Also, it is **not possible to delete any of them** in order to keep the original track of a document that has been edited while the project runs. (2.156)

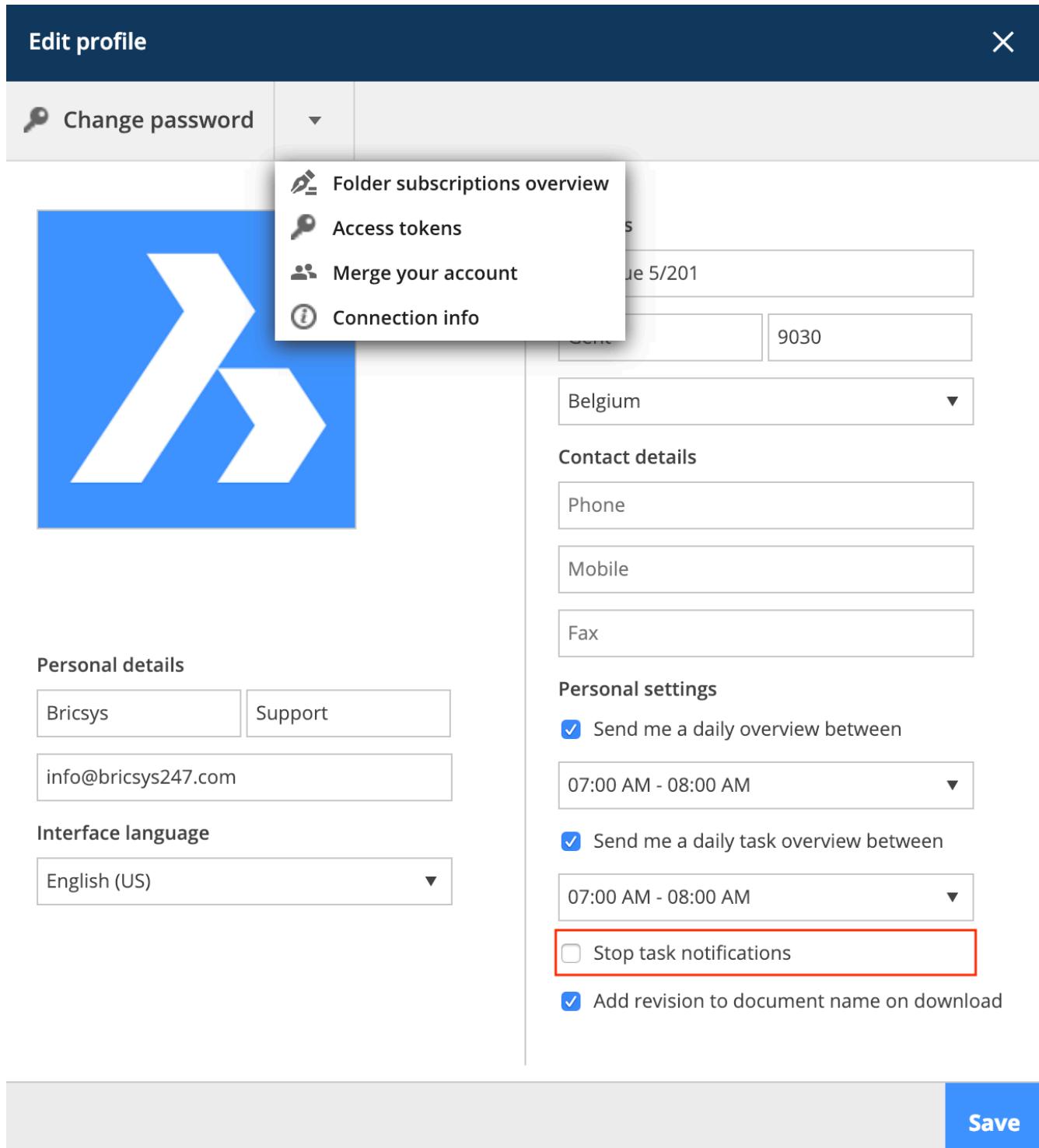

There are two factors that enable a user to delete a workflow:

- Workflow in use or not

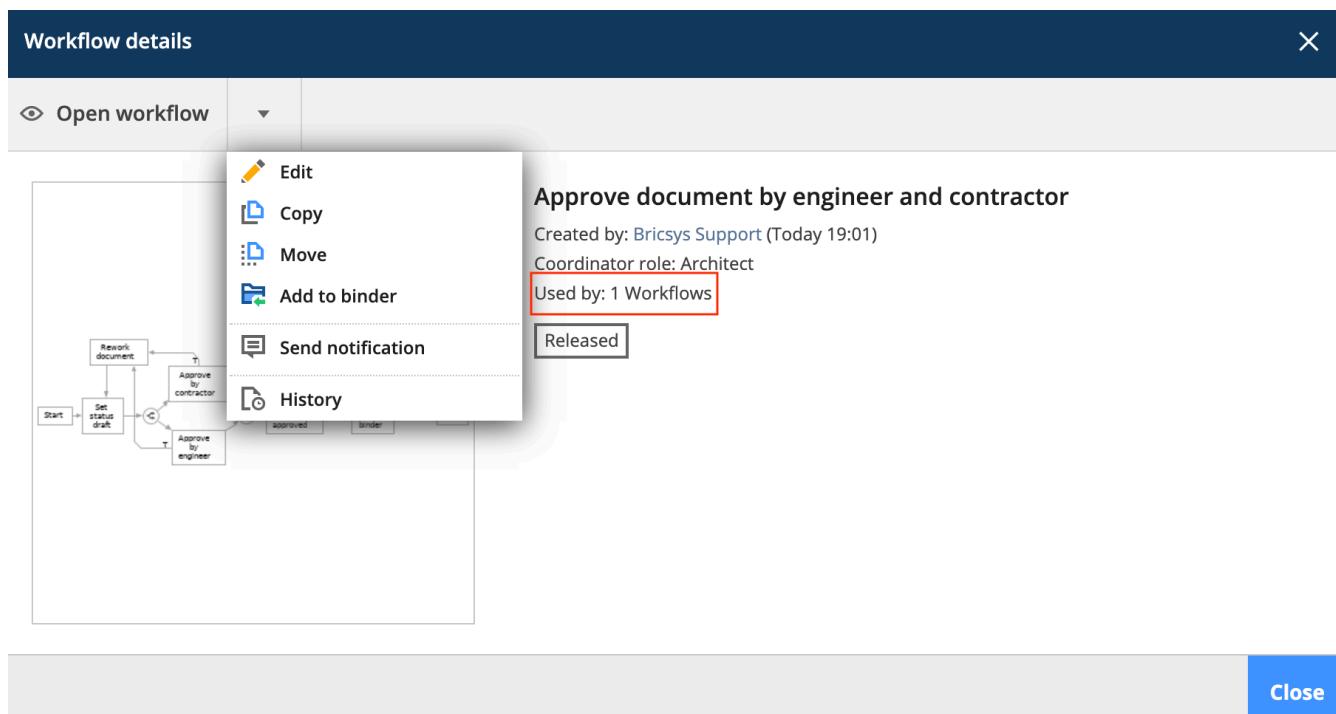
Delete access

First of all you will need delete access for the folder where the workflow is located.

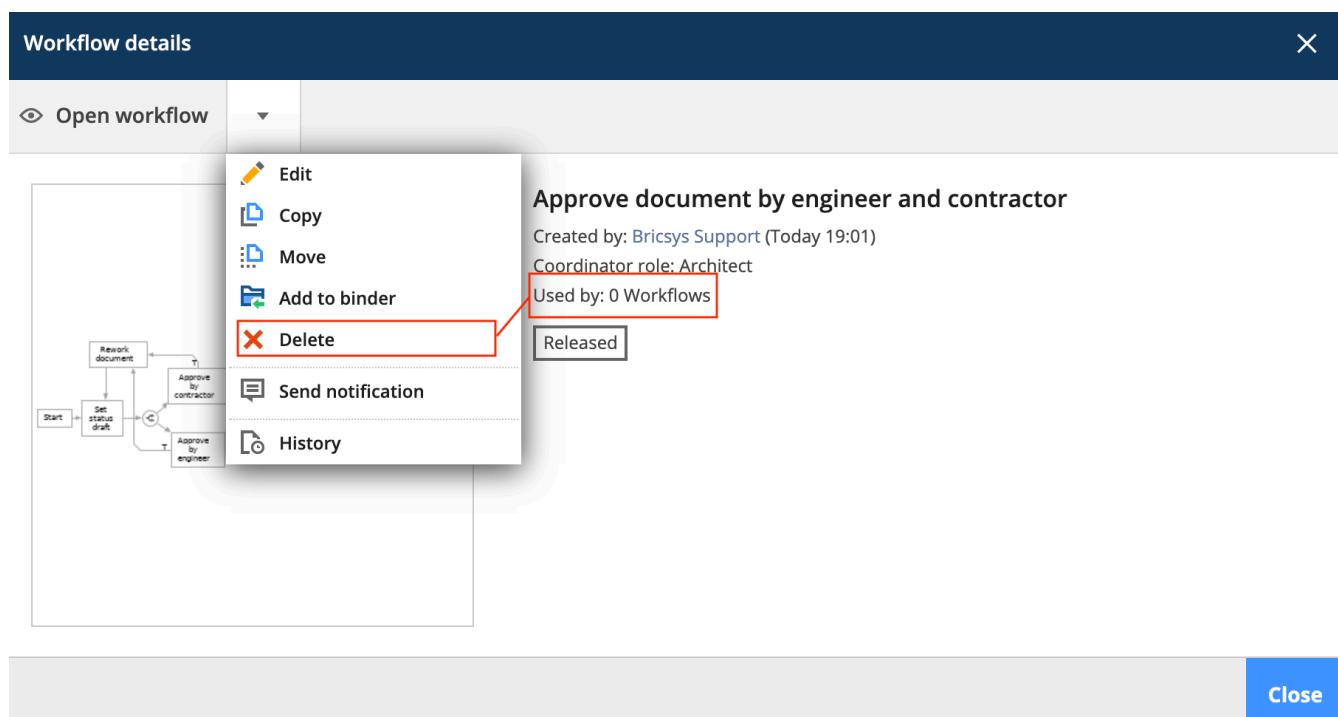
Workflows can only be deleted if they have never been used before. This means that when a workflow has been used or is being used at the moment, the workflow cannot be removed. (2.158) This is measure within Bricsys

24/7 to enforce project continuity, otherwise important data about a document eg. might get lost. (2.159 on the facing page) The only way to delete a workflow is, first - by removing documents where the workflow is attached to. Once the workflow has been removed, you'll see in the workflow details that it is not used anymore.

2.5.5 Why is the workflow task assigned to another user

If you notice that a workflow task is assigned to another user rather than one of the users that are part of the role assigned to the task, it probably has to do with access rights.

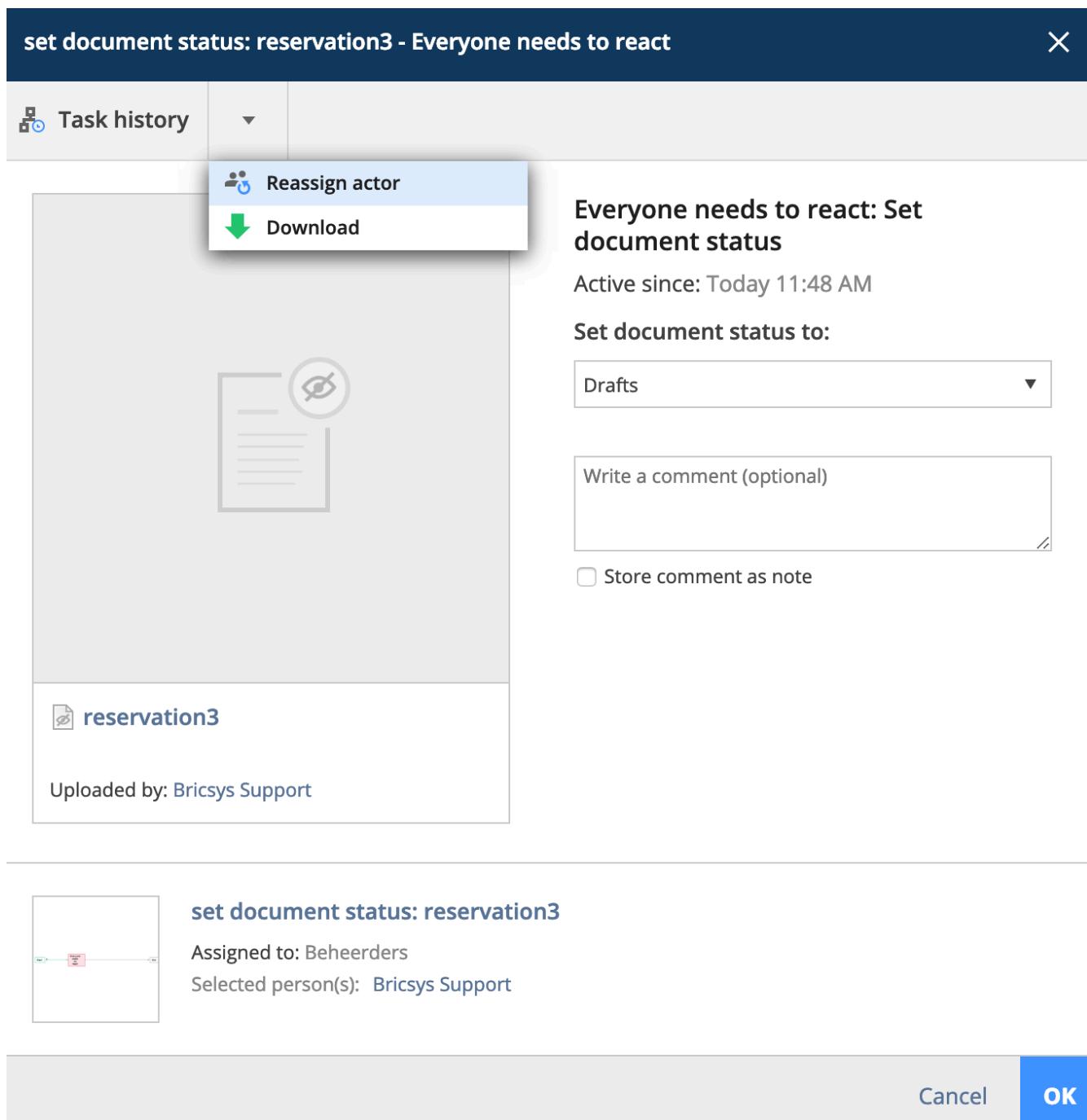
Access rights

Once a workflow activity becomes active and the user doesn't have access to the item, the workflow coordinator will be assigned automatically to the activity. To fix this, an administrator of the project will need to [give the role of the user access to the folder](#) in order to view the item.

Reassign actor

Once this is done, the coordinator of the workflow can open the task assigned to his or her name and use the "reassign" action in the menu. (2.160)

2.5.6 I don't see a specific user when sending a notification

When sending a notification or message you can only select the users that have access rights to the document. If the user you want to send the notification to cannot see the item, the system won't show that user in the list of recipients.

2.5.7 How do I reassign a workflow task to another user

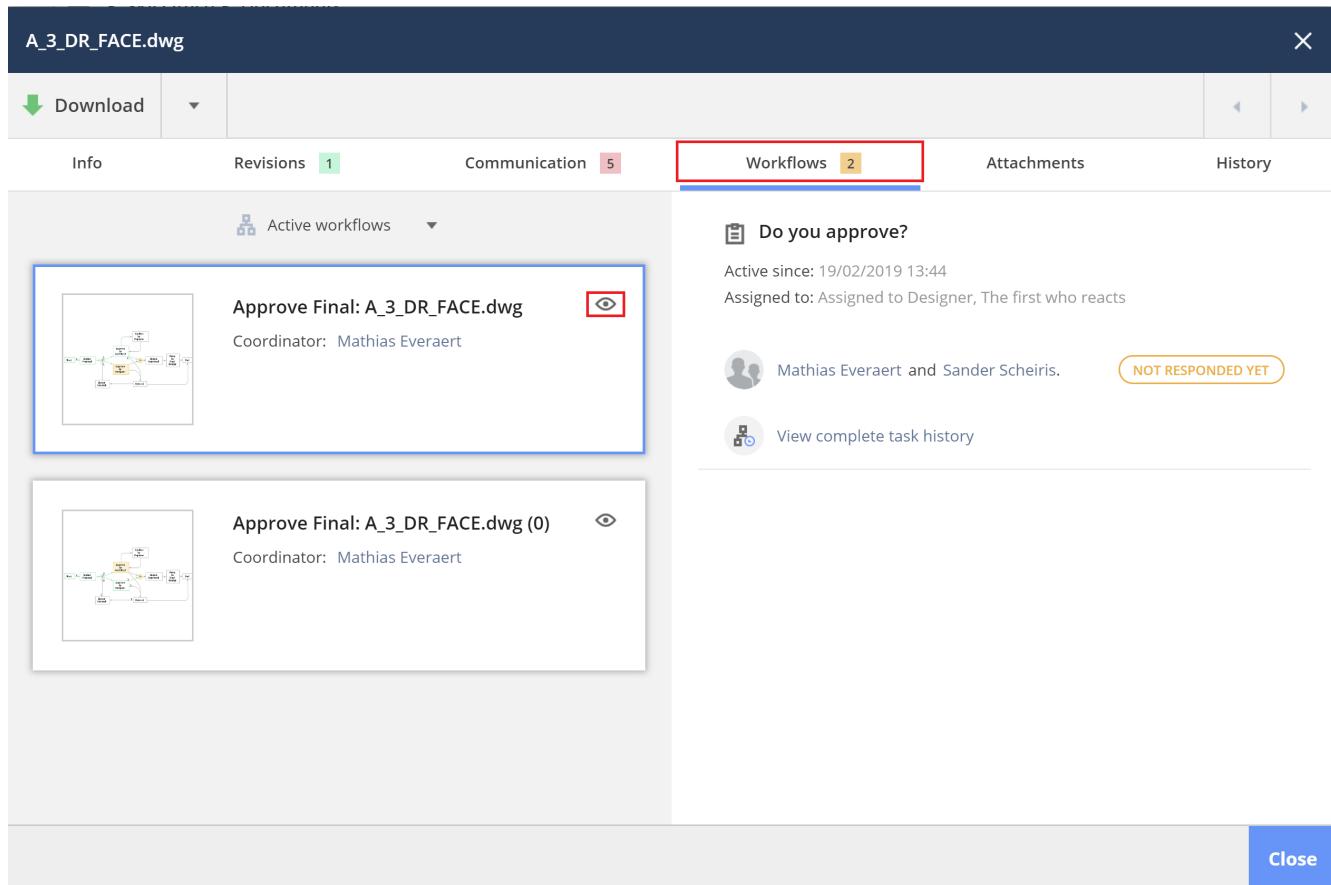
With Bricsys 24/7 it's possible to reassign one specific workflow task or all the workflow tasks from one user to another user. There are two users that can reassign a workflow task to another user:

- the workflow coordinator
- the project administrator

The workflow coordinator can open a task and reassign that individual task to another user: 1. Click on the document. 2. Click on "Workflow" tab. 3. Select an active workflow on the left side of the window and click on the 'eye' icon. (2.161) 4. Click on one task underneath "Tasks" tab. (2.162 on the next page)

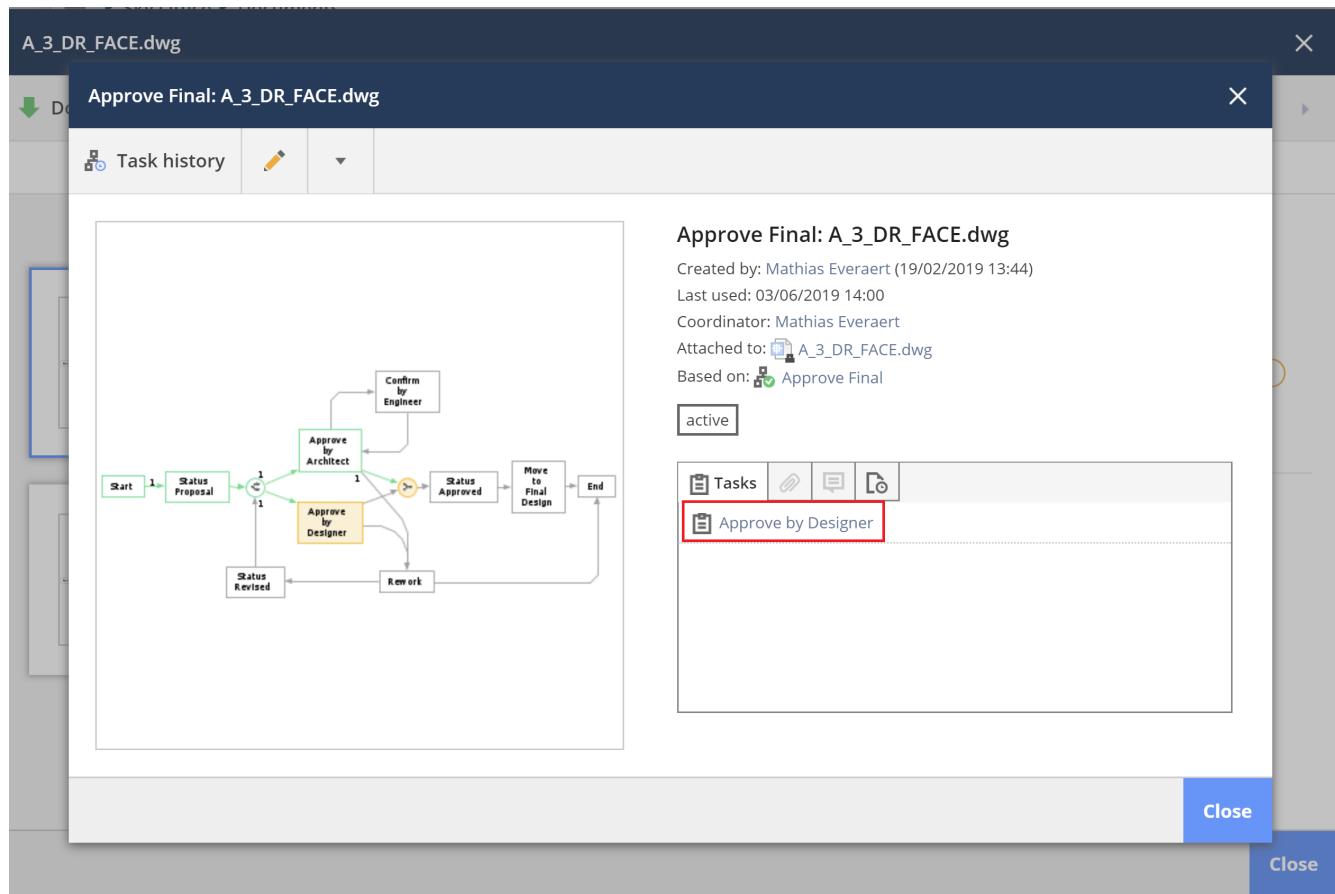
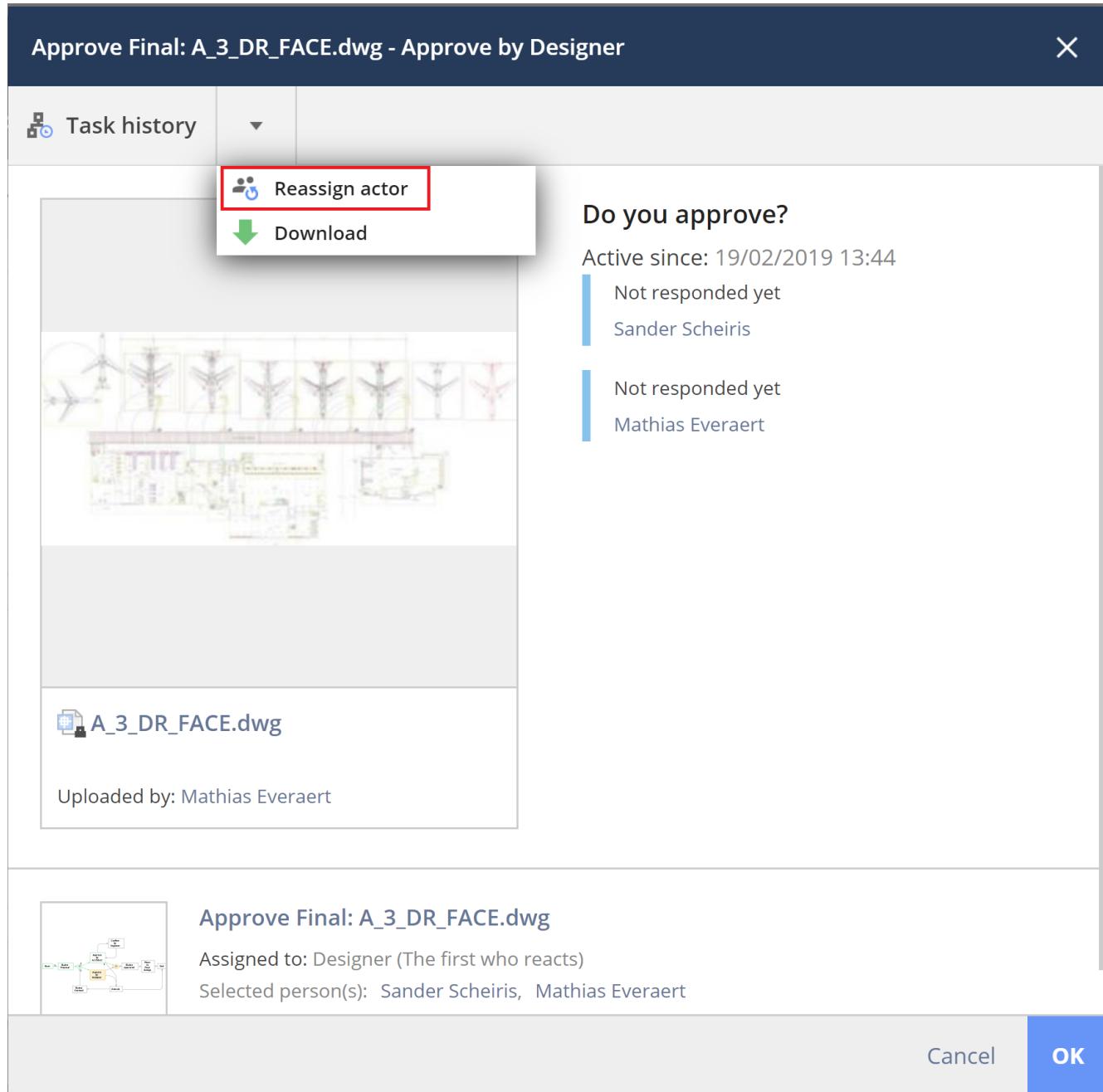


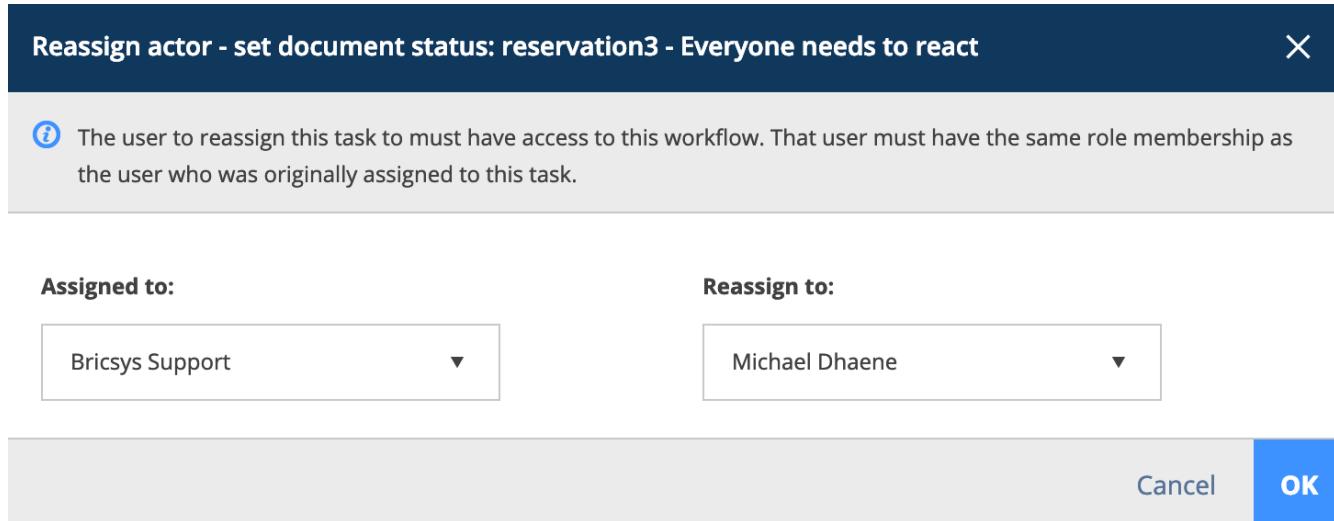

2.5.8 I can't send notifications about a document

When you want to send a notification and don't find the notification action for the document you're viewing, it's because the administrator in the project has disabled the option for you to see other users. If you need to send a notification, you should contact the project administrator to change the [settings of the role](#) you're part of.

2.5.9 I don't see all applications in the app bar

The applications in Bricsys 24/7 are visible in the app bar on the left and their visibility depends on two factors:

- Folder type
- Access

Folder type

Each app represents a different folder type. The more folder types you have in a project the more possible apps that will be available. Eg. In order to have the address book app you need to create a folder of type address book.

Access

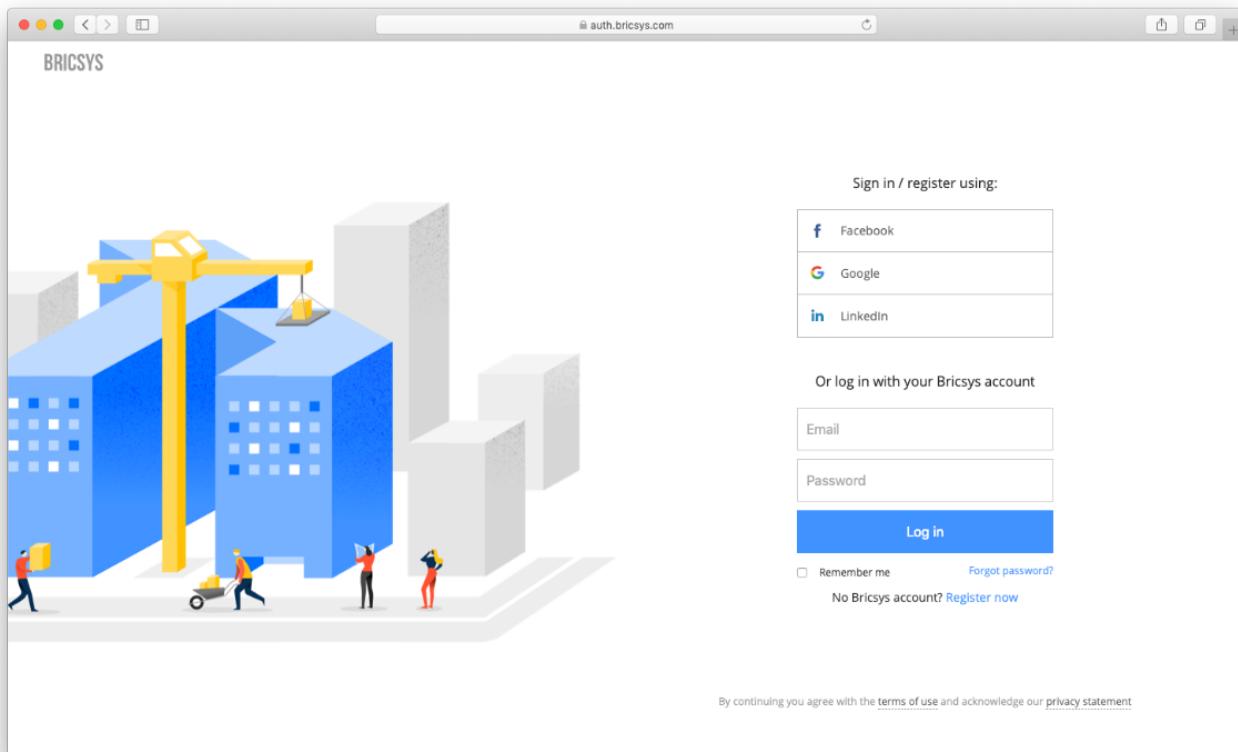
The other factor is your access. If you have an address book folder in your project but you don't have access to it, the address book app will not be available. The administrator of the project is the only one who can create folders and set access. If you are an administrator you can take a look at our [Add Folder](#) section which takes you through all the steps to create a new folder.

2.5.10 Problems logging in using the new Secure Login page

Why is there a new login system?

In December 2019 we transformed our logging system into a new unified login page for Bricsys 24/7 users. This new system will allow you and your users to access Bricsys 24/7, the Bricsys website, and other Bricsys products in a **more secure way**. Below you can find the new Bricsys 24/7 unified login page. (2.165)

What's changing?

Not that much. After the update, users will be able to log in with their current credentials. They will further be prompted to reset their password since our password requirements have been updated. If they can't remember their password, they should use the forgot password link.

Exception Users with a username other than their email will need to sign up for a new Bricsys account. Afterwards they can log in on the Bricsys24/7 website with their new Bricsys account. They will be asked to verify their old Bricsys24/7 credentials in order to access their projects.
